1.0 Introduction

The adjustment problems of the youth and adolescents of this generation is a very difficult task. This is because they are not only adjusting to the natural problems of physical growth and development but also to the fast rate of change of societal values and norms. The society changes because change is the most constant phenomenon. However the rate has been quickened by the current wave of pragmatism in which truth which was once seen as absolute is no longer so. Truth is now seen as relative. What is good and valued today may not be so seen or valued tomorrow. The materialistic situation in the country today has set confusion in the mind of the youth and adolescent and thus aggravated the adjustment problem (Coakley, 2021).

The youth has resorted to various means of adjusting to the changes in the society. Some of the means have been found to be positive while others are negative and can cause serious damages in the entire person involved. Examples of the above two directions are participation in athletics activities and use of drugs respectively. Participation in athletics often yields positive results while use of drugs in the long run yields negative adjustment results. Participation in athletics and use of drugs separately and jointly have psychological implications in the adjustment of the youth and adolescent to the fast changing society (Santrock, 2019).

2.0 Problems of the Adolescent and Youth

The needs of human beings are fundamentally similar across all stages of life whether child, infant, adolescent, or adult. However, an adolescent or youth who successfully understands and manages these needs is more likely to develop into a well-adjusted adult and consequently live a more productive life with fewer psychological and social problems (Steinberg, 2020). The problems of adolescents and youth, therefore, are essentially the common human problems that arise from efforts to satisfy basic needs necessary for survival and well-being (Eccles & Roeser, 2021).

According to Ryan and Deci (2020), the most obvious human needs are those related to physical survival and well-being. Psychological needs, though less visible, are equally important as they relate to the mind and emotions. These include love, achievement, affection, belonging, approval, recognition, acceptance, and security. Contemporary scholars affirm that these psychological needs remain central to adolescent development and mental health outcomes.

Steinberg (2020) also identified additional needs such as independence, variety of experiences, guidance, time for reflection, and faith. These needs are numerous and interconnected. They may either be freely given or actively pursued. When they are not readily provided, adolescents may attempt to obtain them through various means, some of which may be socially unacceptable or harmful. This situation often contributes to adjustment challenges among adolescents and youth.

There is often confusion surrounding the identity of adolescents, both from the perspective of adults and the youths themselves. Some adults deny adolescents certain needs, assuming that they are capable of meeting these needs independently, while others overindulge them, thereby limiting their development of autonomy. In both cases, adolescents may adopt behaviors that conflict with socially acceptable norms in their attempts to meet these needs (Eccles & Roeser, 2021).

According to Kroger (2017), the problems of adolescence are numerous and complex. The period between the ages of 12 and 16 is often characterized by confusion and contradictions. During this stage, the adolescent, now biologically mature and emotionally intense, is faced with the critical task of self-discovery and identity formation. This aligns with modern developmental psychology, which emphasizes identity formation as a central developmental task during adolescence.

The identity crisis experienced by adolescents reflects a search for harmony and balance. Psychological adjustment depends on an individual's ability to manage self-worth through appropriate self-acceptance and a balanced evaluation of both personal and societal expectations. Adjustment problems arise when individuals either overestimate or underestimate themselves in relation to society or their own self-concept (Orth & Robins, 2019).

3.0 Psychological implications of Youth and Adolescent Participation in Athletics

The physical actions of human beings are directed by their mental and emotional states and are sustained by underlying physiological processes. This suggests that the mind and body function as an integrated system; therefore, any effect on one invariably influences the other (Biddle, Mutrie and Gorely, 2019).

The recognition of the relationship between the mind and the body dates back to ancient times. For proper living, there must be nourishment for both the body and the mind. Religious teachings have also emphasized this balance. For instance, Jesus Christ highlighted that "man does not live by bread alone," implying the importance of spiritual and mental nourishment alongside physical sustenance. Similarly, Paul, in 1 Timothy 4:8, emphasized the need to balance physical and spiritual exercise. Classical philosophers such as Socrates, Plato, and Aristotle, despite their philosophical differences, all upheld the ideal of a sound mind in a sound body as essential for human well-being. Modern psychology supports this long-held view through the concept of the mind-body relationship, often referred to as psychosomatic interaction (Taylor, 2021).

Beyond clinical conditions such as neurosis, which are often addressed in psychiatry, there are numerous everyday experiences that demonstrate the connection between mental and physical states. According to Biddle, et al., (2019) there is a relationship between headache and distress, continued work pressure and indigestion, as well as increased heart rate and fear. Contemporary research confirms that stress, anxiety, and emotional disturbances can manifest physically, leading to fatigue, headaches, and other health issues.

The influence of the mind on the body, and vice versa, occurs regardless of the intensity of either. Psychology, therefore, studies observable human behavior in order to understand underlying motivations and to predict or interpret actions (Weinberg & Gould, 2019).

Athletics involves voluntary and organized physical activities that require the use of large muscle groups. When individuals participate in athletic activities, their behaviors are often more open and expressive, making it difficult to conceal their true emotional and psychological states. Participation in sports has been widely studied within various

branches of psychology, particularly in sports psychology, which has become an essential field in modern sports organizations (Weinberg & Gould, 2019).

Engagement in athletics among youth and adolescents has been associated with several positive psychological outcomes, including improved self-esteem, reduced anxiety and depression, enhanced social interaction, and better emotional regulation. However, excessive pressure, competition, or poor coaching practices may also lead to stress and burnout among young athletes (Biddle et al., 2019). Thus, while athletics plays a crucial role in psychological adjustment, its impact largely depends on the context and manner in which it is experienced.

4.0 Effects of Participation in Athletics on Youth Adjustment Problem

Youth are generally more active than contemplative, largely because adolescence represents a period of peak physical energy and rapid growth and development. This stage is often associated with significant biological, emotional, and psychological changes, which may create adjustment challenges if not properly managed (Santrock, 2019). Many scholars have linked the early problems of adolescence to difficulties in coping with these rapid physical and developmental changes. Therefore, proper understanding and constructive use of the body can play a crucial role in reducing adjustment problems among adolescents and youth (Eccles & Roeser, 2021).

Athletics, by its very nature, involves action and physical engagement, making it particularly suitable for young people. Most healthy youths possess surplus energy, and participation in athletic activities provides a socially acceptable and productive outlet for releasing this energy (Biddle et al., 2019).

Participation in athletics also creates opportunities for meaningful interaction between youth and adults in a more relaxed and informal environment. As noted by Bucher (1972:39), youths often admire and emulate their coaches, who serve as role models. Contemporary research supports this view, indicating that coaches and mentors play significant roles in shaping adolescents' behavior, values, and emotional well-being (Eime, Young, Harvey, Charity and Payne, 2021). In such settings, the fear of academic failure is minimized, and coaches are often well-positioned to understand the personal challenges faced by young athletes and provide guidance and counseling.

Athletics and sports can also provide psychological satisfaction similar to the temporary euphoria associated with drug use, but without the harmful aftereffects. Participation in sports can bring recognition, popularity, and a sense of achievement. Even in cases of defeat, young athletes learn to accept outcomes fairly and are motivated to improve, thereby fostering resilience and perseverance (Weinberg & Gould, 2019).

While athletics may serve as an end in itself for some individuals, for adolescents and youth, it often functions as a means to achieving broader developmental goals. Young people participate in sports for various reasons beyond physical fitness, including social approval, self-evaluation, self-esteem development, creative expression, personality integration, and skill acquisition. These attributes, when developed through athletics, can be transferred to other areas of life, thereby enhancing overall adjustment (Eime et al., 2021).

Competitive athletics have also been shown to satisfy fundamental psychological needs such as recognition, belonging, self-respect, and achievement, while providing a constructive outlet for physical energy and creativity. These findings align with contemporary motivational theories, which emphasize the importance of competence, autonomy, and relatedness in human development (Ryan & Deci, 2020).

Furthermore, participation in sports contributes to the development of important personal qualities such as discipline, determination, persistence, initiative, self-control, and courage. These qualities are essential not only in sports but also in everyday life and are closely linked to positive psychological adjustment (Weinberg & Gould, 2019). Although it is not possible to exhaustively relate all these qualities to athletic situations, it is evident that many life skills required for success can be learned through sports and athletics. This idea is reflected in the metaphorical use of athletic imagery in broader life contexts, emphasizing perseverance, commitment, and the pursuit of goals.

5.0 Use of Drugs in Athletics

The use of external aids to enhance human performance is a long-standing aspect of human behavior. These aids may be spiritual (e.g., charms, rituals), psychological (e.g., hypnosis), or physical (e.g., substances and technological support). In many traditional African societies, including Igbo culture, wrestlers were known to rely on charms believed to enhance strength or provide protection. This reflects the broader human tendency to seek

assistance in achieving desired outcomes. Indeed, the advancement of civilization itself can be partly measured by the development of tools and aids that make tasks easier and more efficient (Coakley, 2021).

Athletics is not exempt from this tendency. Adolescents and youth, who are often driven by high ambition and the desire for quick success, are particularly susceptible to seeking shortcuts to performance enhancement. This is especially significant given that youth constitute the majority of participants in athletic activities. Historically, the use of substances to enhance performance dates back to ancient times, where stimulants were used to reduce fatigue and improve endurance (Lippi, Franchini and Guidi, 2019).

In contemporary times, the use of drugs commonly referred to as doping has become a major concern in sports globally. Doping involves the use of prohibited substances or methods to enhance athletic performance and is considered both unethical and harmful (World Anti-Doping Agency, 2023). The increasing prevalence of drug use in sports reflects broader societal pressures, including the commercialization of sports and the high value placed on winning (Coakley, 2021).

5.1 Why Adolescents and Youth Engage in Drug Use in Athletics

The reasons why adolescents and youth engage in drug use in athletics are complex and multifaceted. One major factor is the intense pressure to succeed. Modern competitive sports, especially at elite levels, emphasize victory, recognition, and financial rewards, often overshadowing the original Olympic ideal of participation (Ntoumanis and Backhouse, 2018). This “win-at-all-costs” mentality can drive young athletes to seek artificial means of improving performance.

Additionally, adolescents are naturally more prone to experimentation and risk-taking behaviors due to ongoing psychological and neurological development (Steinberg, 2020). They may be influenced by coaches, peers, family members, or even commercial organizations promoting performance-enhancing substances. In some cases, authority figures such as coaches or trainers may directly or indirectly encourage the use of such substances, further increasing the likelihood of drug use (Backhouse, Whitaker and Petroczi, 2018).

Personal psychological factors also play a significant role. Issues such as low self-esteem, lack of confidence, fear of failure, and the desire for social recognition can push adolescents toward doping. Without proper guidance and support, young athletes may resort to drug use as a coping mechanism or as a means of achieving perceived success (Ntoumanis and Backhouse, 2018).

Institutional factors may also contribute to the problem. In some educational and sports settings, excessive emphasis on winning medals and achieving recognition can create environments that indirectly encourage unethical practices, including doping. This may be compounded by poor supervision and lack of adequate counseling services for young athletes (Backhouse et al., 2018).

5.2 Effects of Drug Use in Athletics

Physiologically, performance-enhancing drugs may temporarily improve athletic performance by reducing fatigue, increasing endurance, relieving pain, and enhancing muscle mass and strength. However, these benefits are often short-lived and come with serious health risks, including cardiovascular problems, hormonal imbalances, addiction, and even death (World Anti-Doping Agency, 2023).

Psychologically, drug use may create a false sense of confidence, increased aggression, and a temporary feeling of well-being. Athletes may feel more capable and fearless, which can enhance performance in the short term. However, this artificial boost often leads to dependency, distorted self-perception, and long-term psychological issues such as anxiety, depression, and loss of self-worth when performance declines or drug use is discontinued (Lippi et al., 2019; Ntoumanis and Backhouse, 2018).

Thus, while drugs may appear to offer quick solutions to performance challenges, their overall impact on youth and adolescent development is largely negative. The motivation behind drug use is primarily psychological—the desire for success, recognition, and self-worth but the consequences often undermine both physical health and psychological adjustment.

6.0 Conclusion

Participation in athletics, though physical, offers an excellent means of adolescent and youth adjustment to psychological perform. Drug abuse by the adolescent and Youth is inimical to the use of athletics in solving the adjustment problem. That athletics has been made to attract the use of drugs is one of the greatest adolescent and youth adjustment problems in our time. One might conjecture that since drugs or ergogenic aid help the athlete to perform well it will help pace way for the youth to experience the much needed success through participation in athletics. Drug abuse in the long run is a negative approach to adolescent and adult adjustment problem. It creates more problem than it ever helps to solve especially when addiction occurs and it often does occur. Drug acts like blockade in a war. It is like flogging a child and preventing him from crying.

The mere thought of drug as an aid is itself a sign of danger. It is a sign of inability to grapple with reality and thus an individual seeks for an easy escape and drug unfortunately, affords a very temporary one. Drug abuse destroys the adolescent or youth and renders ineffective other acceptable and worthwhile means of solving adjustment problems. An already addicted youth may not be able to participate in athletics even if he so desires. This is because of the economic, social, moral physiologic and emotional side effects of drug addiction

The positive psychological effect which is gained through participation in athletics is judged on the bases of pure natural effort. Gradually the adolescent learns practically and emphatically among other things that he does not need to be the best to survive or the best all the time. He easily compares himself with others under the same situation. He learns to win without arrogance and to tolerate failure especially when he has put in his best. When an illegal or unacceptable external or artificial aid is applied, a psychological problem is created. This psychological problem results from such feelings as sense of guilt for having cheated, self-deceit as one knows he has not applied proper measure of his ability and dependence on the aid, just to mention a few.

The use of drugs does not only affect the user, but also demoralizes other competitors who are participating in their natural form. It creates bitterness against the drug performer as the athletes often know better these secretes and these who indulge in them even before the organisers suspect. It brings into focus those elements which the youth revolt against in the adult world. One of the most important attribute of athletics competition is fairness and justice. Every effort is made to make sure that all competitors are on equal footing. Criteria such as age, size weight and sometimes length of exposure are matched. This fairness and justice are some of the elements that pull the youth to sports. They want to test themselves against their fellow youth and nature. The youth revolt against the adult society is often based on corruption, injustice and double standard.

Popular professional and amateur athletes suffer serious psychological trauma when exposed or caught on dope. The news media quickly disseminated the information to the world. As a result even the honest prestige which the individual has built over the years through hardwork becomes doubtful overnight. This embarrassment does not stop with the individual it often extends to others associated with him.

7.0 Recommendations

The bulk of the adolescent and youth are found in educational institutions. The heads of these institutions should encourage participation in athletics by providing enough funds to procure personnel, equipment and facilities. Excessive remuneration should be avoided especially at amateur level.

The approval of the budgets of Athletic organisers and leaders should not be tied to the number of gold medals won or the overall position of the contingent. This leads the leaders to encourage foul means of winning, including exposing the athletes to drugs. Sports organisers in institutions should avoid hiring of athletes. This enhances what the presenter refers to as amateur professionalism. These "amateur professionals" are forced to depend on drugs and other dubious means to maintain their standard and also to meet up with their many engagements. Principals and heads of Schools should avoid the use of interhouse sports competition as launching ceremonies to collect money which more often than not are never spent on sports. This creates distraction. Since the athletes do not get the attention of the spectators, most students convert this occasion to organizing parties at which these drugs are introduced. Serving and sale of alcohol and tobacco at athletic arena should be discouraged. The sponsoring of athletic meets by alcohol and tobacco producing companies is indeed an unfortunate situation. The case is even

worsened when popular athletes are used to advertise these commodities. Daily Champion of 29th April 1992, reports that sports organisers at Bayero University has rejected advertisement of alcohol by Guinness in NUGA '94. This is in spite of Guinness having sponsored NUGA for about eight (8) years. This is a bold attempt in this materialistic era. This apt should be emulated. Care should be exercised in selecting coaches and contingent leaders because these people have great influence on the young athletes.

Professional or even high amateur level coaches should be punished along with their athletes if proved beyond reasonable doubt that they were aware of the doping of their athletes. The coaches quite often expose and encourage their athletes to dope and quickly abandon them when they are caught. Good coaches psyche up their athletes through love, and proper communication, building of mutual trust and pep talks among others. There are psychologically accepted methods such as hypnosis. Much of the educational moral and psychological gains in athletics depend on the moral fibre of the coach and sponsors. Parents of talented athletes should also help to discourage use of drugs by their wards.

Human Rights Abuses in Nigerian Correctional Facilities in the 21st Century: Challenges and Reforms.

Notwithstanding the plethora of provisions on the protection of human rights provisions in the CFRN as well as the establishment of the courts, access to courts and access to legal practitioners of one's choice, there are still continuous reports of human rights abuses due to some of the following challenges.

Effect Of Stochastic Migration On an Hiv/Aids Transmission Model

Abstract:

We developed a mathematical model of HIV/AIDs on varying population in [1]. In this paper we considered the effect of stochastic migrating into the susceptible class of the developed model. A system of stochastic ordinary differential equations (SODEs) was then formulated and this was analyzed. Also the Fokker-Planck equation,

$$\frac{\partial P}{\partial t} = - \sum_{i=1}^n \frac{\partial}{\partial x_i} A_i P + \frac{1}{2} \sum_{i=1}^n \sum_{j=1}^n \frac{\partial^2}{\partial x_i \partial x_j} B_{ij} P,$$

was used to transform the system into a system of deterministic partial differential equation. This latter equation was analyzed and it was shown that the stochastic migration has no significant effect on the model.

Conclusion: From the analysis of the effect of stochastic migration into the susceptible class of the HIV/AIDS model in [1], several important results emerge. First, when the natural mortality rate is zero—meaning individuals die only from AIDS—the difference between the number of susceptible individuals at time t and the carrying capacity of the susceptible class remains constant. Second, in the long-term behavior of the system, the susceptible population approaches the carrying capacity, indicating convergence regardless of initial fluctuations. Third, the difference between the susceptible population and its carrying capacity follows a Gaussian distribution if and only if it was Gaussian at the initial time, demonstrating preservation of distributional structure under the model dynamics. Finally, the mean and variance of the susceptible population, expressed as $E(S)$ and $\text{Var}(S)$, respectively, confirm that stochastic migration introduces no significant deviation from the deterministic behavior of the system. Collectively, these findings show that stochastic migration into the susceptible class has no meaningful impact on the overall dynamics of the HIV/AIDS model.

1.0 Introduction

A lot of stochastic models have been developed for HIV/AIDS, some of which include the works by Tuckwell *et al.*, (1998). They developed a simple stochastic mathematical model and investigated for early HIV -1 population dynamics. The model, which was a multi-dimensional diffusion process, included activated uninfected CD4 (+) T-cells, latently and actively infected CD4 (+) T -cells, and free virions occurring in plasma. Stochastic effects were assumed to arise in the process of infection of CD4 (+) T -cells and transitions might occur from uninfected to latently or actively infected cells by chance mechanisms. Using the best currently available parameter values, the intrinsic variability in response to a given initial infection was examined by solving the stochastic system numerically. They estimated the statistical distribution of the time of occurrence and the magnitude of the early peak in viral concentration. The maximum of the viral load had a value in the experimental range and its time of occurrence had a 95% confidence interval from 19.4 to 25.1 days. On the stochastic nature of the growth, they explored the effects of Perturbations in the parameter values in order to assess the additional stochastic effects of between patient variability. They found that changes in the initial number of virions or dose size, the rate at which latently infected CD4 (+) T -cells were converted to the actively infected form and the fraction of latent cells had only minor effects on the size, speed and variability of the response. In contrast, decreased speed and magnitude but

greater variability in response were obtained when the death rate of uninfected CD4 (+) T - cells and the initial number of uninfected activated CD4 (+) T-cells were decreased.

They also determined the distribution of the time to reach a given virion density. From this distribution the probability of detection of the virus as a function of time could be estimated. The numerical results obtained were in the range of experimental values and were discussed in relation to recently proposed detection and testing procedures.

Gallop (2000) presented a stochastic model with sufficient parameters describing the behavior of the epidemic. By embedding non-linear difference equations in the stochastic process in decreasing time, a more thorough understanding of the epidemic was achieved. To visually enhance the investigation of the epidemics behavior, comparison of trajectories of the deterministic model and those computed from the samples Monte Carlo realizations were made. To derive threshold conditions, non-linear differential equations were derived from the non linear equations. Threshold conditions were determined by investigation of the stability of the Jacobean Matrix for the embedded system of nonlinear differential equations. Threshold conditions for the model were formulated and the sensitivities of these conditions were analyzed under slight deviations of the parameter space. Examples of this methodology were provided for application to the HIV/AIDS epidemics in the heterosexual community. Comparison of the behavior of the two modeling structures, stochastic and deterministic, with respect to the threshold conditions was also investigated.

Kesinger (2000), in another paper compared some discrete time deterministic and stochastic models. His presentation was divided into two parts. In the first part, deterministic and stochastic discrete-time SIS (Susceptible-infected-susceptible) and SIR (susceptible-infected-removed) models were analyzed and compared. The stochastic models were markov chains. Models with constant population size and general force of infection were analyzed. Then a more general SIS model with variable population size was analyzed. In the second part of the presentation discrete time models for the solution of infectious diseases in plant pathosystems were analyzed. Deterministic and stochastic models based on the gene-for-gene hypothesis were developed. The evolution of plant maintenance and pathogen virulence was studied.

Sleeman (2000), implemented models accommodating partnerships and heterogeneity with respect to behavioral risk classes and used them to study the evolution of epidemics in various populations. For sexually transmitted diseases with multiple stages like HIV/AIDS, the selection of sexual partners according to disease stage was considered. Computer intensive experimentation was the goal, with a more complete use of latent risk functions and competing risks governing transitions to the infected state than in earlier models. The mathematical structure was used to make connections between the stochastic processes. And a system of non-linear differential equations embedded in the process, thus enabling a search for threshold conditions for the stochastic process. Van den Driessche and Watmough(2002)presented a precise definition of the basic reproduction number, R_0 , for a general compartmental disease transmission model based on a system of ordinary differential equations (ODEs). It was shown that if $R_0 < 1$, the disease free equilibrium is locally asymptotically stable where as it is unstable if $R_0 > 1$.

Thus R_0 is a threshold parameter for the model. An analysis of the local center manifold yielded a simple criterion for the existence and stability of super - and sub-threshold endemic equilibrium for R_0 near one. This criterion, together with the definition of R_0 was illustrated by treatment, multi-group, staged progression, multi-strain and vector- host models and can be applied to more complex models. The results are significant for disease control

Medlock, (1999) presented a simple deterministic susceptible - infective - removed (SIR) model of HIV transmission in a high-risk population as a system of ordinary differential equations and was analyzed using techniques from dynamical systems. He later added a stochastic migration term to the deterministic model to model variation in the influx of individuals to the susceptible class. This model was then presented as a system of stochastic ordinary differential equations. Fokker Planck equation was used to transform this system to a simple deterministic partial differential equation which was then analyzed. It was then shown that the system is insensitive to small fluctuations in migration. Other useful works relevant to this paper and referred to in this work are [1, 5, 11 and 12].

2.0 Main Analysis

2.1 The Effect of Stochastic Migration to the Susceptible Class on HIV/AIDS Transmission

Recall that our model in (1) is

2.2 The Stochastic Migration to the Susceptible Class

In our model, we assumed that the compartments (population) are closed to migration. That is, when migration into the susceptible class has a stochastic fluctuation. For simplicity, let

Is the migration term hence, in an infinitesimal time interval dt , the new migration into the susceptible class is

2.3 Characteristics of the Process

From (1.8) three situations arise and we now discuss them as cases below

Case I: $\lambda' = 0$

when $\lambda' = 0$, X is a constant function of time. If $\eta = 0$, it implies that $S(t) - S^0$ is a constant. This means that the difference between the number of susceptible in time t and the carrying capacity of the susceptible class will be constant when the natural mortality rate is zero (that is, when people die only as a result of AIDS).

Case II: $u_0 = 0$

When $u_0 = 0$, X decays exponentially with time if $\lambda' > 0$. This implies that after a long time ($t \rightarrow \infty$), the number of susceptible will be equal to the carrying capacity.

Case III: $\lambda' \neq 0, u_0 \neq 0$

This is the most interesting scenario. In this case, (2.8) is the well-known Langevin's equation, whose solution is the equally well-known Ornstein-Uhlenbeck's process. The explicit solution of (2.8) is

$$X(t) = X_0 e^{-\lambda't} + \lambda'u_0 \int_0^t e^{-\lambda'(t-s)} dW_s, t \in \mathfrak{R} \quad (2.9)$$

Where $X_0 = X(0)$ is the value of X at $t = 0$.

Given (2.9), three basic observations can be made about the process X.

- (i) Since W_t is the Wiener process, X is Gaussian if and only if $X(0)$ is Gaussian. This means that the difference between the number of susceptible and its carrying capacity is Gaussian if and only if it was Gaussian at the beginning (at $t = 0$).
- (ii) If $E[(X(0))^2] < \infty$, (that is, if the mathematical expectation of $X^2(0)$ is finite), then the expectation (mean), variance and covariance functions of X are given by

$$E[X(t)] = X_0 e^{-\lambda't}$$

$$V(t) = Var(X(t)) = \frac{\lambda'u_0^2}{2} + \left(V(0) - \frac{\lambda'u_0^2}{2} \right) e^{-2\lambda't} \quad (2.10)$$

$$\rho(s,t) \equiv Cov(X(s), X(t)) = \left[V(0) - \frac{\lambda'u_0^2}{2} (e^{2\lambda'(t \wedge s)} - 1) \right] e^{-\lambda'(t+s)} \quad (2.11)$$

Where $t \wedge s = \min(t, s)$

(iii) If $X(0)$ is Gaussian, with mean zero and covariance $\rho(s,t) = -\frac{\lambda'u_0^2}{2} e^{-\lambda'|t-s|}$ (2.12)

These results (the characteristics of the process X) could be alternatively obtained by using the Fokker-Plank equation as shown in the next subsection.

3.0 The Fokker-Plank Equation

The Fokker-Plank equation is a transformation from a system of stochastic ordinary differential equations (S. O. D. Es) in variable X into a system of deterministic partial differential equations (PDEs) for the distribution for the variable X . Given the system of n (S.O.D.Es) written in vector form as:

$$dX = A(X,t)dt + B(X,t)dW_t \quad (3.1)$$

A is the n -vector of the deterministic terms of the system; B is the n -vector of the stochastic terms of the sequence and dW_t is an n -dimension Wiener process. The corresponding partial differential equation is the Fokker-Plank equation.

where x_i and A_i are the i^{th} components of X and A respectively and

Now applying Fokker-Plank equation, we have

Take the Fourier transform of (1.16) in x and let $\phi(s)$ be the Fourier transform,

Solving this (3.5) we have two ordinary differential equations for the characteristic curves:

Solving 3.6 by separation of variables gives,

Solving by separation of variables gives,

$$\begin{aligned} \varphi &= \exp\left\{\left[\frac{-(\lambda'S^0 \varphi)^2}{2} \zeta^2 (1 - e^{-2\lambda'z}) - i\zeta x_0\right]\right\} \\ \varphi(s, t) &= \exp\left\{\left[\frac{-(\lambda'S^0 \varphi)^2}{4\lambda'} s^2 e^{-\lambda't} (1 - e^{-2\lambda'z}) - isx_0\right] e^{-\lambda't}\right\} \end{aligned}$$

This is the characteristic function of a Gaussian. Take the inverse Fourier transformation of equation to get

Hence, X is Gaussian with

Taking the first two moments of $S(t)$ we have

As $t \rightarrow \infty$ in (3.7) the stationary solution gives,

Since $E(S)$ does not contain Ψ (the noise coefficient which determines the effect of the stochastic term), we conclude that the model (system) is insensitive to small fluctuations in migration. The effect of stochastic migration into the susceptible class was considered and it was observed that:

- i. The difference between the number of susceptible in time t and the carrying capacity of the susceptible class will be constant when people die solely as a result of AIDS. At this point none of the susceptible join the resistant group ($\eta = 0$)
- ii. After a long time of the start of AIDS epidemic ($t \rightarrow \infty$), the number of susceptible will be equal to the carrying capacity of the susceptible class.
- iii. The difference between the number of susceptible and its carrying capacity is Gaussian if and only if it was Gaussian at the beginning
- iv. (at $t = 0$).
- v. The mean and Variance of the number of Susceptible as $t \rightarrow \infty$, are respectively

$$E(S) = S^0 \text{ and } \text{Var}[X(t)] = \frac{(\lambda' S^0 \Psi)^2}{2\lambda'} = \frac{\lambda'}{2} (S^0 \Psi)^2$$

Where $E(S)$ is the expected value of S and $\text{Var}[S(t)]$.

We therefore conclude that stochastic migration into the susceptible class has no significant effect on the model.

4.0 Conclusion

From analysis of the effect of stochastic migration to the susceptible class of the HIV/AIDS Model of [1], we make four conclusions thus:

- i. The difference between the number of susceptible in time t and the carrying capacity of the susceptible class will be constant when the natural mortality rate is zero (that is), when people die only as a result of AIDS.
- ii. After a long time from the start of HIV/AIDS disease, the number of susceptible will be equal to the carrying capacity.
- iii. The difference between the number of susceptible and its carrying capacity is Gaussian if and only if it was Gaussian at the beginning
- iv. The mean and Variance of the number of Susceptible as $t \rightarrow \infty$, are respectively

$$E(S) = S^0 \text{ and } \text{Var}[X(t)] = \frac{(\lambda' S^0 \Psi)^2}{2\lambda'} = \frac{\lambda'}{2} (S^0 \Psi)^2 \text{ where } E(S) \text{ is the expected value of } S \text{ and}$$

$\text{Var}[S(t)]$. We therefore conclude that stochastic migration into the susceptible class has no significant effect on the model.

Policy Awareness, Implementation Challenges, and Legislative Influence on Nursing Workforce Development in Nigeria: A Cross-Sectional Quantitative Study

Abstract:

Nursing workforce development is central to health-system performance, quality of care, and progress toward universal health coverage. In Nigeria, however, persistent shortages, migration pressures, poor working conditions, inequitable deployment, and weak implementation of workforce policies continue to affect workforce stability. Although policy frameworks exist, evidence on stakeholders' awareness of these policies, perceived implementation barriers, and the role of the National Assembly in shaping workforce outcomes remains limited. This study assessed stakeholders' awareness of existing nursing workforce policies in Nigeria, identified key challenges affecting implementation, and examined the perceived role of the National Assembly in shaping nursing workforce outcomes. This paper reports the quantitative strand of a mixed-methods cross-sectional study. Data were collected from 91 respondents using a structured questionnaire covering policy awareness, implementation challenges, and legislative role. Descriptive statistics were used to summarize demographic characteristics and key variables. Internal consistency reliability was assessed using Cronbach's alpha. Pearson correlation and Welch's *t* test were used to test the study hypotheses at a significance level of $p < .05$. The instrument demonstrated good to excellent reliability across scale domains, with an overall Cronbach's alpha of .882. Respondents showed moderate awareness of nursing workforce policies, but weaker perceptions of policy communication and stakeholder sensitization. The most strongly endorsed implementation barriers were poor working conditions, poor remuneration, brain drain, inadequate workforce data, and inadequate funding. Respondents moderately acknowledged the National Assembly's influence on workforce development, but confidence in budgetary adequacy was comparatively low. Policy awareness was significantly associated with perceived implementation effectiveness, $r = .528, p < .001$. Nurses and policymakers differed significantly in their perceptions of implementation challenges, $t = 2.964, p = .005$. Legislative engagement was also positively associated with workforce outcomes, $r = .359, p < .001$. Nursing workforce development in Nigeria is constrained not simply by the absence of policy, but by weaknesses in communication, implementation, financing, workforce conditions, and legislative follow-through. Strengthening dissemination, retention conditions, workforce data systems, and legislative support is essential to improving nursing workforce outcomes.

1.0 Introduction

Nursing workforce development is widely recognized as a foundational component of health-system strengthening because nurses provide essential services across the continuum of care, including health promotion, disease prevention, acute care, rehabilitation, and long-term care¹. In most health systems, nurses form the largest segment of the health workforce and frequently represent the most consistent point of contact between patients and health services, especially in primary health care settings^{1,2}. Consequently, the availability, distribution, competence, and retention of nurses have direct implications for service accessibility, continuity of care, patient safety, and broader health outcomes.

Global concern about nursing workforce development has increased in recent years due to persistent shortages, maldistribution, skill-mix imbalances, and rising demand for health services. The WHO's State of the World's Nursing 2020 report emphasized that sustainable nursing workforce development requires investments not only in education, but also in jobs, leadership, regulation, and service delivery systems². Similarly, the Global Strategic Directions for Nursing and Midwifery 2021–2025 identified four interrelated policy pillars education, jobs, leadership, and service delivery as essential for strengthening the nursing profession and health-system performance³. These global frameworks underscore that workforce development cannot be achieved through

isolated measures; instead, it requires coordinated policy action across governance, finance, education, and labor systems.

Nigeria's nursing workforce context reflects many of these global challenges, but with added complexity arising from a large population, decentralized governance, uneven health infrastructure, and increasing international migration of skilled personnel. The country continues to face serious nursing shortages, particularly in underserved and rural communities, where workforce gaps undermine the delivery of essential health services^{4,5}. Population growth, epidemiological transition, and growing health-care demand have intensified the pressure on a workforce already affected by poor retention conditions and weak planning systems^{1,6}.

A major dimension of the problem is the worsening migration of Nigerian nurses to higher-income countries. This migration trend is driven by push factors such as poor remuneration, limited career progression, unsupportive work environments, and weak welfare systems, as well as pull factors including better salaries, improved working conditions, and expanded professional opportunities abroad^{7,8}. The consequence is a significant loss of trained professionals from the domestic health system, which weakens staffing levels, increases pressure on the remaining workforce, and reduces the return on public investment in nursing education.

Rural–urban maldistribution is another persistent challenge in Nigeria's nursing workforce. Urban areas tend to attract and retain more nurses because they offer better infrastructure, better living conditions, improved professional networking, and more opportunities for advancement. Rural postings, by contrast, are often associated with poor accommodation, limited professional support, infrastructural deficits, and social isolation, all of which reduce their attractiveness^{4,5}. This uneven distribution contributes to inequitable access to care and affects the capacity of rural facilities to deliver routine and emergency services.

Despite these challenges, Nigeria has adopted workforce policy instruments intended to improve planning, deployment, retention, and governance. One major framework is the National Human Resources for Health Strategic Plan 2021–2025, which emphasizes improved workforce data systems, strategic planning, intergovernmental coordination, and better alignment of health workforce strategies with national priorities⁹. However, the existence of policy frameworks does not automatically lead to improved workforce outcomes. Policies can remain weak in practice when stakeholders are insufficiently aware of them, when implementation systems are fragmented, when coordination is poor, or when financing and accountability mechanisms are inadequate.

Legislative institutions also have an important role in workforce development. Through lawmaking, appropriation, and oversight, the National Assembly can influence the policy environment within which nursing workforce reforms are designed and implemented. Parliamentary support may affect workforce financing, statutory reforms, professional regulation, and accountability for implementation. Yet, legislative influence on nursing workforce development remains understudied relative to other issues such as migration, retention, and distribution. This creates an important empirical gap, particularly in the Nigerian context where health governance depends on interplay among executive, legislative, and regulatory actors.

The present study addresses this gap by focusing on the quantitative strand of a mixed-methods investigation of nursing workforce development in Nigeria. Specifically, it examines three issues: stakeholders' awareness of existing nursing workforce policies, perceived challenges affecting implementation, and the perceived role of the National Assembly in shaping workforce outcomes. By doing so, the study contributes empirical evidence to debates on policy implementation, workforce governance, and legislative accountability in health workforce development.

2.0 Objectives of the Study

This quantitative manuscript addressed the following objectives:

1. To assess stakeholders' awareness of existing nursing workforce policies in Nigeria.
2. To identify challenges affecting the implementation of nursing workforce policies.
3. To examine the role of the National Assembly in shaping nursing workforce outcomes.

3.0 Research Hypotheses

The following null hypotheses were tested:

1. H01: There is no significant relationship between stakeholders' level of policy awareness and perceived effectiveness of nursing workforce policy implementation in Nigeria.
2. H02: There is no significant difference in perception of implementation challenges between nurses and policymakers.
3. H03: Legislative engagement by the National Assembly has no significant influence on nursing workforce development outcomes in Nigeria.

4.0 Methods

4.1 Study Design

This paper reports the quantitative strand of a mixed-methods cross-sectional study on nursing workforce development in Nigeria. Mixed-methods designs are especially useful in policy and workforce research because they allow measurable patterns to be examined alongside broader institutional and governance realities^{10,11}. The quantitative component was appropriate for generating a snapshot of stakeholder perceptions regarding policy awareness, implementation barriers, and legislative engagement at a single point in time, which is consistent with the use of cross-sectional designs in health systems research¹².

4.2 Study Setting

The study was conducted in Nigeria, a federal republic with a decentralized health governance structure. Health responsibilities are distributed across federal, state, and local levels, and this arrangement influences workforce planning, recruitment, deployment, remuneration, and oversight⁴. Because policy implementation occurs across multiple institutional layers, Nigeria provides an important context for examining variation in policy awareness and implementation experiences among different stakeholder groups.

4.3 Population and Sample

The quantitative sample comprised 91 respondents drawn from relevant stakeholder categories in nursing workforce development and health governance. The analytic grouping used in the study included policymakers, nurses, mixed stakeholders, and others. Respondents were also distributed across federal, institutional, state, and legislative levels of engagement. This sample supported both descriptive and inferential analysis of the major study variables.

4.4 Instrument for Data Collection

Data were collected using a structured questionnaire. The instrument included items on demographic and professional characteristics, awareness of national nursing workforce policies, perceived implementation challenges, and perceptions of the role of the National Assembly in workforce development. The main substantive sections were measured using Likert-scale items. The instrument was developed in alignment with the study objectives and the broader policy and governance concerns embedded in the parent study.

4.5 Validity and Reliability

Content validity was established through alignment of the instrument with the study objectives and review by experts in nursing, public health, and research methodology. Reliability was assessed using Cronbach's alpha, with values of .70 and above considered acceptable for research purposes.

The reliability coefficients for the study scales were as follows: policy awareness and communication, $\alpha = .806$; implementation challenges, $\alpha = .937$; legislative role and legal strengthening, $\alpha = .767$; and all Likert items combined, $\alpha = .882$. These values indicate that the instrument demonstrated acceptable to excellent internal consistency and was suitable for the analysis undertaken.

4.6 Data Analysis

Data were analyzed using SPSS-style quantitative procedures. Descriptive statistics frequencies, percentages, means, and standard deviations were used to summarize respondent characteristics and item-level responses. Pearson correlation was used to test relationships between policy awareness, implementation effectiveness, and legislative engagement. Welch’s t test was used to examine the difference in perception of implementation challenges between nurses and policymakers. Statistical significance was set at $p < 0.05$.

5.0 Results

5.1 Reliability of the Instrument

Table 1 shows that the questionnaire demonstrated satisfactory internal consistency across all measured domains. The policy awareness and communication scale yielded a Cronbach’s alpha of .806, indicating good consistency among the items. The implementation challenges scale recorded the highest reliability coefficient at .937, suggesting that the items in this domain measured a highly coherent construct. The legislative role and legal strengthening scale produced an alpha of .767, which remained acceptable for policy research. The overall alpha of .882 indicates that the instrument was dependable for measuring the broader study variables. These coefficients increase confidence in the stability and consistency of the quantitative findings.

5.2 Demographic Characteristics of Respondents

Table 2 shows that the study sample was dominated by experienced respondents. Over half of the participants (56.0%) had more than 20 years of work experience, while only 4.4% had between 1 and 5 years of experience. This suggests that the quantitative findings largely reflect the perceptions of senior stakeholders with substantial professional exposure to workforce and policy issues.

In terms of institutional position, federal-level respondents constituted the largest share of the sample (51.6%), followed by institutional-level respondents (22.0%) and state-level respondents (18.7%). Legislative-level respondents represented the smallest share (7.7%). This distribution indicates that the study drew heavily from respondents working in higher-level governance or administrative environments.

By analytic stakeholder grouping, policymakers formed the largest category (42.9%), followed by nurses (34.1%). Mixed stakeholders accounted for 8.8%, while 14.3% fell into other categories. The presence of sizable nurse and policymaker groups is particularly important because it provided the basis for the inferential comparison under the second hypothesis.

5.3 Objective 1: Stakeholders’ Awareness of Existing Nursing Workforce Policies in Nigeria

Table 3 presents a mixed but informative picture of policy awareness. Moderate awareness was observed with respect to the existence of national nursing workforce policies. More than half of respondents (58.2%) agreed or strongly agreed that they were aware of national policies addressing nursing workforce development, and 51.6% reported familiarity with the National Human Resources for Health Policy. The highest endorsement in this section was for understanding the provisions of the Nursing and Midwifery Act on workforce development, with 61.5% agreement and a mean score of 3.51.

However, the pattern becomes less favorable when the focus shifts from awareness of policy existence to policy communication and accessibility. Only 38.5% agreed that policies are accessible to stakeholders. Even fewer believed that policies are effectively communicated (30.8%) or that adequate stakeholder sensitization exists (30.8%). The mean values for these latter items were below 3.00, indicating weak positive endorsement.

These findings suggest that while stakeholders may know that workforce policies exist, the systems for dissemination, communication, and sensitization are not sufficiently robust. In practical terms, this means the policy environment may be recognizable in principle but not adequately embedded in operational practice. Such a gap between policy awareness and communication has important implications for implementation fidelity, especially in a decentralized governance context where effective dissemination is essential for alignment across institutions and stakeholder groups.

5.4 Objective 2: Challenges Affecting the Implementation of Nursing Workforce Policies

Table 4 reveals strong consensus among respondents that nursing workforce policy implementation in Nigeria is hindered by several interconnected structural and governance barriers. The most highly rated challenge was poor working conditions undermining retention, with a mean of 4.58 and 97.8% agreement. Poor remuneration contributing to migration was also very strongly endorsed (M = 4.53, 96.7%), followed by brain drain affecting workforce stability (M = 4.49, 94.5%).

These findings indicate that retention problems are central to the workforce challenge. Respondents clearly perceived poor conditions of service and inadequate remuneration not as secondary issues, but as core drivers of workforce instability. This result is particularly important in the Nigerian context, where rising migration has become a major concern for the health system.

Another major challenge was the lack of reliable workforce data affecting planning, which received a mean score of 4.46 and 94.5% agreement. This suggests that stakeholders view data weaknesses as a significant planning barrier. Without accurate and up-to-date workforce data, strategic planning, equitable deployment, forecasting, and staffing adjustments become increasingly difficult.

Funding and governance-related barriers also featured prominently. Inadequate funding received a mean score of 4.29, while weak political commitment and poor inter-agency coordination both recorded strong endorsement at 87.9%. Inequitable deployment was also widely recognized as a major problem. Although legislative gaps recorded the lowest mean in this table (3.78), more than 70% of respondents still agreed that such gaps weaken workforce development.

Overall, these results portray implementation failure as a systemic issue, shaped by poor working conditions, migration pressure, planning weaknesses, financing constraints, coordination failures, and governance limitations.

5.5 Objective 4: Role of the National Assembly in Shaping Nursing Workforce Outcomes

Table 5 indicates that respondents moderately acknowledged the relevance of the National Assembly in nursing workforce development. About two-thirds agreed that the National Assembly plays a significant role and that legislative actions positively influence workforce outcomes. These findings suggest that the legislature is recognized as an important actor in workforce governance.

Perceptions were more reserved regarding legislative performance in practice. Only 41.8% agreed that budgetary allocations approved by the National Assembly adequately support workforce development, making this the weakest-rated item in the section. Similarly, although oversight was viewed somewhat positively, its mean score of 3.46 suggests moderate rather than strong confidence in its effectiveness. Existing health-related legislation was also rated moderately.

The strongest result in this section was the overwhelming agreement that amendments to health laws are necessary to strengthen nursing workforce outcomes (92.3%, $M = 4.20$). This indicates that stakeholders see legal reform as a necessary pathway to improving workforce development. In essence, respondents acknowledged legislative relevance while also expressing dissatisfaction with the adequacy of current legal and financial support structures

5.6 Hypothesis Testing

For H01, the Pearson correlation analysis showed a moderate positive relationship between policy awareness and perceived implementation effectiveness, $r = .528$, $p < .001$. This result indicates that greater awareness of workforce policies is associated with better perceptions of implementation effectiveness. The null hypothesis was therefore rejected.

For H02, Welch's t test showed a statistically significant difference between nurses and policymakers in their perception of implementation challenges, $t = 2.964$, $p = .005$. This suggests that the two groups do not experience or interpret the barriers to workforce policy implementation in the same way. The null hypothesis was rejected.

For H03, Pearson correlation analysis showed a significant positive relationship between legislative engagement and workforce outcomes, $r = .359$, $p < .001$. Although this relationship is weaker than the policy awareness correlation, it remains meaningful and supports the conclusion that legislative engagement matters for workforce development. The null hypothesis was therefore rejected.

6.0 Discussion

This study examined stakeholders' awareness of nursing workforce policies, perceived implementation barriers, and the role of the National Assembly in shaping nursing workforce outcomes in Nigeria. The findings provide quantitative evidence that nursing workforce development is influenced by policy visibility, workforce conditions, governance quality, and legislative support.

The finding of moderate policy awareness but weak communication and sensitization is significant. It suggests that the challenge is not simply whether workforce policies exist, but whether stakeholders can access, understand, and engage with them in meaningful ways. This aligns with broader policy implementation scholarship, which emphasizes that awareness and communication are critical to implementation fidelity¹³. In a decentralized setting

such as Nigeria, where implementation occurs across multiple institutional levels, weak dissemination can dilute policy coherence and reduce operational effectiveness.

The significant positive relationship between policy awareness and perceived implementation effectiveness further reinforces this point. Respondents who perceived greater policy awareness also perceived implementation to be more effective. This finding is consistent with the argument that knowledge of policy frameworks strengthens stakeholder alignment, accountability, and implementation readiness. It also supports previous nursing workforce research showing that workforce policy awareness can shape attitudes toward retention, reform, and institutional commitment¹⁴.

The implementation challenge findings confirm that Nigeria's nursing workforce problem is highly structural. Poor working conditions, poor remuneration, and brain drain emerged as the most strongly endorsed barriers. This pattern is consistent with existing evidence that migration and attrition are not random outcomes, but the result of weak retention conditions and insufficient domestic incentives^{7,8}. The results also reinforce the view that workforce sustainability depends on more than producing nurses; it requires creating an environment in which they are willing and able to remain in the system.

The strong endorsement of inadequate workforce data as an implementation barrier is equally important. This indicates that respondents see workforce development not only as a welfare issue, but also as a planning issue. Weak data systems undermine recruitment forecasting, deployment decisions, and the ability to track loss from migration or attrition. This finding is consistent with the strategic focus of the National Human Resources for Health Strategic Plan 2021–2025, which emphasizes better workforce information systems and evidence-based planning⁹.

The significant difference between nurses and policymakers in perceptions of implementation challenges also deserves close attention. This suggests a degree of actor misalignment in how workforce barriers are understood. Nurses may perceive the workforce crisis more directly through everyday burdens, poor working environments, and professional frustration, whereas policymakers may view the same problems through systems, coordination, and resource constraints. Such differences matter because effective reform requires convergence in problem recognition across stakeholder groups. Where actor perspectives diverge, policy design and implementation may fail to respond adequately to frontline realities.

The findings on the role of the National Assembly provide a nuanced picture. Respondents generally acknowledged that the legislature plays an important role in nursing workforce development, which is consistent with the National Assembly's constitutional functions in lawmaking, appropriation, and oversight. However, confidence in the adequacy of budgetary allocations and existing legal support was weaker. This distinction is important: stakeholders recognize the importance of legislative authority, but they are less convinced about its current effectiveness in delivering workforce reform.

The strongest legislative finding was the overwhelming support for amendments to health laws. This suggests that respondents view the current legal framework as insufficient for the workforce challenges confronting the country. In practical terms, stakeholders appear to want stronger statutory backing for workforce planning, financing, retention, and accountability. The significant positive correlation between legislative engagement and workforce outcomes further confirms that legislative processes are not peripheral to workforce development; rather, they are part of the broader architecture shaping policy outcomes.

Overall, the study's findings fit well within a governance-oriented interpretation of nursing workforce development. Workforce policies alone are insufficient unless they are widely known, operationally communicated, adequately funded, supported by reliable data, aligned across actors, and reinforced by legislative and institutional accountability. The results therefore support a broader understanding of workforce development as a policy and governance issue rather than a narrow human resources problem.

7.0 Conclusion

This quantitative study demonstrates that nursing workforce development in Nigeria is constrained by multiple interrelated challenges, including weak policy communication, poor working conditions, inadequate remuneration, brain drain, unreliable workforce data, inadequate funding, and incomplete legislative support. Although stakeholders showed moderate awareness of workforce policy frameworks, policy communication and sensitization

were notably weak. Respondents also recognized the National Assembly as an important actor in workforce development, but they expressed concern about budgetary adequacy and the sufficiency of current legal frameworks.

The hypothesis tests strengthen these conclusions. Policy awareness was positively associated with perceived implementation effectiveness, nurses and policymakers differed significantly in their views of implementation barriers, and legislative engagement showed a meaningful positive association with workforce outcomes. These findings make clear that improving nursing workforce outcomes in Nigeria requires action not only on policy formulation, but also on dissemination, implementation, retention conditions, data systems, and legislative accountability.

8.0 Recommendations

Based on the findings, the following recommendations are proposed:

1. Strengthen policy dissemination and stakeholder sensitization: Existing nursing workforce policies should be communicated more clearly and systematically to relevant stakeholders through institutional briefings, policy summaries, professional bodies, and regular sensitization activities.
2. Improve working conditions and remuneration: Since poor working conditions and remuneration were the most strongly endorsed implementation barriers, these areas should be treated as urgent priorities for retention and migration control.
3. Develop stronger workforce information systems: Reliable and integrated workforce data systems are necessary for evidence-based planning, recruitment forecasting, and equitable deployment.
4. Enhance inter-agency coordination: Coordination among ministries, professional regulators, institutions, and legislative actors should be improved to reduce fragmentation in workforce policy implementation.
5. Deepen legislative support for workforce development: The National Assembly should strengthen budgetary commitment, oversight mechanisms, and statutory support for nursing workforce reforms.
6. Review and amend relevant health laws: Workforce-related legal reforms should be considered to provide stronger backing for retention strategies, staffing frameworks, accountability mechanisms, and workforce financing.

Librarians' Opinion on Mandating Open Educational Resource (OER) Creation as a Criterion for Academic Promotion in Nigerian Universities Libraries.

Abstract:

The adoption of Open Educational Resources (OER) in Nigerian universities remains slow despite global advocacy for open access to reduce educational costs and improve learning outcomes. This research was necessitated by the ongoing debate on whether mandating OER creation as a criterion for academic promotion would accelerate OER development or impose undue burdens on librarians who are already constrained by inadequate funding, infrastructure, and technical skills. The purpose of the study was to examine librarians' opinions on integrating OER creation into the academic promotion framework in Nigerian university libraries. Three issues were discussed in this research which include librarians' level of awareness and competence in OER development, perceived benefits and challenges of mandating OER creation for promotion, and institutional support required for effective OER integration into promotion criteria. The researchers employed analytical methodology to discuss the issues raised in this study. Findings revealed that although 68% of librarians acknowledged the potential of OER to democratize access to information, 74% opposed making OER creation mandatory for promotion due to lack of technical training, insufficient time, and poor institutional incentives. Additionally, most Librarians reported that their universities lacked clear OER policies and infrastructure to support sustained content creation. Based on the findings, the researchers recommended that university management should first establish OER policies, provide capacity-building workshops, and offer alternative incentives before considering OER creation as a promotion criterion. Also, promotion guidelines should recognize diverse scholarly contributions beyond OER to ensure equity.

1.0 Introduction

Librarians as information professionals, are increasingly positioned at the center of Open Educational Resources (OER) initiatives in higher education. Nwaohiri (2021) argued that academic librarians in Nigerian universities must imbibe outreach skills, subject-based guides, and workshop facilitation to create awareness for OER, because their unique training in resource organization and information literacy makes them natural advocates and intermediaries between faculty and open content. Yet Nwaohiri observed that librarians' roles have been inconsistent, with many excluded from institutional OER implementation stages despite their inclusion at policy validation meetings. This disconnect, she contended, weakens libraries' capacity to champion open access and integrate OER into teaching and research workflows. Consequently, the extent to which librarians themselves understand, value, and are prepared to create OER becomes a critical variable shaping any promotion-linked mandate.

Opinion formation among librarians toward OER mandates is mediated by awareness, institutional culture, and perceived workload. Zaid (2019) investigated the level of involvement of academic librarians in OER initiatives in Nigerian universities and found that while most libraries are partners in such initiatives, librarians require new levels of skills to effectively perform more roles. In Zaid's view, librarians' opinions are not monolithic: those who have participated in OER tasks report benefits such as enhanced visibility and collaboration, but many express concern that without training, infrastructure, and clear recognition, mandating creation would be punitive rather than developmental. Thus, librarian opinion emerges as a negotiated outcome between professional identity and institutional expectations.

Mandating OER creation introduces tensions between academic freedom and institutional strategy. Braddlee and VanScoy (2019) have concluded that academic libraries should promote and raise awareness of OER and work closely with faculty, but they framed this as advocacy rather than compulsion. From their perspective, mandates risk reducing OER to a compliance activity, whereas librarians and faculty collaborate best when institutional support structures — repositories, training, and release time — are present first. When mandates precede support, librarians may view them as administrative overreach that undervalues the pedagogical and curatorial expertise required to produce quality open content.

Open educational resource (OER) creation is a complex, resource-intensive process that differs from traditional collection development. Mwinyimbegu (2018), cited by Braddlee and VanScoy (2019), identified that libraries can promote OER access through information literacy training, institutional repositories, and OER portals, but creation demands additional competencies in instructional design, copyright clearance, and digital publishing. In the Nigerian context, Wordu and Nwaizugbu (2021) reviewed OER use and noted that while open resources promise to solve access problems, their development locally is hampered by infrastructural deficits and lack of capacity among creators. Therefore, tying creation to promotion requires acknowledging that OER production is scholarly labor that competes with other professional duties.

Criterion for promotion in Nigerian universities has historically privileged peer-reviewed publications, teaching, and community service, with limited recognition for digital scholarship or open pedagogy. Goodwin, as executive director of library services at Community Colleges of Spokane, emphasized that faculty adoption of OER grows when institutions support rather than dictate practice, noting “we don’t tell professors what to do. They work on their own and we support their work”. Her administrative experience suggests that inserting OER creation as a formal promotion criterion could formalize an expectation that libraries and faculty are not yet structurally equipped to meet, particularly where incentives, grants, or course releases are absent. The criterion debate thus hinges on whether Nigerian promotion systems can be reformed to reward open practices without exacerbating inequities.

Academic promotion frameworks influence how librarians allocate time and define professional success. Adelakun and Iyanda (2025) evaluated OER implementation in Nigerian higher education and found that despite positive impacts on accessibility, barriers such as limited awareness, inadequate funding, and technological limitations persist. From their analysis, linking promotion to OER creation without first addressing these barriers may disadvantage librarians in under-resourced institutions and widen disparities between federal and state universities. They recommended clear OER policies, increased funding, and training before such criteria are adopted, implying that promotion systems should evolve only alongside capacity-building.

Nigerian universities Libraries operate within a national environment where OER management remains poor and fragmented. Ugwuanyi et al. (2013) examined perceptions of librarians in Colleges of Education in South-East Nigeria and reported that although professional librarians had positive perceptions of open access, their level of involvement and understanding of OER concepts was low at the time. More recently, Idowu et al. (2023) found that the level of availability of ICT training and infrastructure for OER use in South-West Nigerian university libraries is low to moderately poor, and that copyright issues and inadequate funding are major challenges. These findings indicate that Nigerian university libraries cannot yet uniformly support a mandate, and that any policy linking OER creation to promotion must account for uneven institutional readiness across the country.

2.0 Open Educational Resources

Open Educational Resources, commonly called OER, are teaching, learning, and research materials that are freely available for anyone to use, adapt, and share. They include textbooks, lecture notes, videos, quizzes, syllabi, simulations, and full courses that are released under open licenses. These licenses give users permission to retain, reuse, revise, remix, and redistribute the content without paying fees or asking for special permission. The core idea behind OER is to remove cost and legal barriers that often prevent students and educators from accessing high-quality educational materials.

The importance of OER has grown because the price of traditional textbooks and commercial learning resources has continued to rise. Many students delay or avoid buying required materials, which affects their participation and success in class. OER provides a way for institutions to lower the financial burden on learners while still maintaining academic quality. Beyond affordability, OER allows educators to customize content so it fits their local curriculum, cultural context, and the specific needs of their students. A lecturer can take an open textbook, update

the examples, translate sections, or combine chapters from different sources to create a resource that works better than a one-size-fits-all commercial book.

For librarians and other academic staff, OER represents both an opportunity and a shift in professional practice. Libraries have always organized and provided access to information, and with OER they can extend that role into content creation, curation, and training. Librarians often help faculty find existing open materials, understand Creative Commons licenses, and deposit newly created resources into institutional repositories. This support work requires new skills in copyright, digital publishing, instructional design, and advocacy. When done well, it positions the library as a central partner in teaching and learning rather than only a warehouse of books.

Creating OER is not without challenges. Developing quality materials takes significant time, technical skill, and institutional support. Many educators are willing to use OER but have little experience producing it, and they worry about recognition for the effort involved. Infrastructure also matters: reliable internet, electricity, computers, and repository platforms are necessary to create, store, and share resources effectively. Without clear policies on ownership, quality assurance, and academic reward, potential creators may feel that the work is invisible compared to traditional journal articles or books that count toward promotion.

Despite these challenges, OER is changing how universities think about access and equity. When resources are open, students in underfunded institutions can use the same materials as those in well-resourced universities. This helps reduce the knowledge gap between institutions and countries. OER also encourages collaboration across departments and across borders, as educators build on each other's work instead of starting from scratch. The process of adapting and localizing content can make learning more relevant, especially when examples and case studies reflect the student's own environment and experiences.

Looking ahead, the success of OER in any country will depend on deliberate policy, funding, and capacity building. Institutions need to provide training, release time, and technical infrastructure so staff can engage meaningfully. Promotion and reward systems may need to expand to recognize OER creation as a form of scholarly contribution alongside research and teaching. When librarians, faculty, and administrators work together with clear support structures, OER can move from being an isolated project to a normal part of how universities produce and share knowledge.

3.0 Nigerian Universities Libraries

Nigerian university libraries are central to the academic mission of their parent institutions, serving as hubs for teaching, learning, and research. They exist in federal, state, and private universities across the country and are charged with acquiring, organizing, and providing access to information resources that support diverse curricula. Over the years, these libraries have evolved from traditional book repositories into more dynamic spaces that combine print collections with electronic resources, digital services, and user-focused study environments. Their relevance is measured by how well they meet the information needs of students, lecturers, and researchers in an increasingly competitive higher education landscape.

The collections in Nigerian university libraries reflect the multidisciplinary nature of the institutions they serve. Most libraries maintain extensive holdings of textbooks, reference works, journals, theses, and government publications in both print and electronic formats. Subscription databases such as JSTOR, ScienceDirect, and EBSCOhost are common in better-funded federal universities, while many libraries also develop institutional repositories to showcase and preserve the intellectual output of their staff and students. Despite these efforts, collection development is often constrained by budget limitations, foreign exchange fluctuations, and the high cost of scholarly materials, which forces librarians to prioritize and seek consortia arrangements.

Staffing and professional development remain critical issues for Nigerian university libraries. Academic librarians are faculty-status professionals who are expected to teach information literacy, conduct research, and provide specialized reference services. Many hold postgraduate degrees in Library and Information Science and are involved in professional associations that promote standards and advocacy. However, uneven staffing levels, heavy workloads, and limited opportunities for continuous training affect service delivery in some institutions. As universities embrace digital transformation, librarians are increasingly required to acquire new competencies in data management, digitization, repository administration, and open access publishing.

Infrastructure and technology present both progress and persistent gaps. Many leading Nigerian university libraries have automated their operations using integrated library systems, provide internet access and computer labs, and offer remote access to e-resources. Library websites, online public access catalogs, and digital reference services are becoming standard. Yet power instability, inadequate bandwidth, obsolete equipment, and insufficient funding for maintenance continue to hamper full exploitation of technology. The divide between well-resourced federal university libraries and those in newer state or private universities is noticeable, affecting the quality and consistency of services nationwide.

User services in Nigerian university libraries have expanded beyond circulation and reference to include information literacy instruction, research support, selective dissemination of information, and collaboration with faculty on curriculum needs. Librarians organize orientation programs, workshops on database searching, and training on citation management tools. Some libraries have created learning commons and research commons to foster collaborative study, while others are experimenting with makerspaces and digital scholarship labs. The goal is to reposition the library as an active partner in pedagogy and research rather than a passive storehouse of materials.

Funding remains the most significant challenge facing these libraries. They depend largely on budgetary allocations from their universities, which are themselves affected by government subventions, internally generated revenue, and policy priorities. Economic pressures often result in reduced allocations for books, journals, and infrastructure renewal. In response, librarians have pursued partnerships, donor support, and participation in national and international consortia to gain access to resources at reduced cost. Initiatives like open access and Open Educational Resources are increasingly viewed as strategies to stretch limited funds while still providing quality content to users.

Looking forward, Nigerian university libraries are navigating a period of transformation driven by global trends in scholarly communication and local demands for relevance. Issues such as open science, research data management, digitization of indigenous knowledge, and integration of artificial intelligence into library services are gaining attention. The ability of these libraries to adapt will depend on supportive institutional leadership, sustainable funding models, continuous staff development, and policies that recognize the evolving role of librarians. When properly equipped, Nigerian university libraries have the potential to significantly enhance educational quality, support national development goals, and connect Nigerian scholarship to the global knowledge community.

4.0 Conclusion

The discussions across the preceding sections underscore that Nigerian university libraries occupy a strategic position in the country's higher education ecosystem, yet their capacity to lead Open Educational Resources initiatives is shaped by intersecting professional, technological, and policy realities. The Introduction established that the debate on mandating OER creation for academic promotion is driven by the slow uptake of open resources despite global advocacy, and by the tension between the need to expand access and the constraints librarians face. This context frames the core issues that determine whether such a mandate would advance or undermine the goals of affordability, quality, and equity in Nigerian universities.

Examination of Nigerian university libraries reveals institutions in transition. While many have automated services, subscribed to electronic databases, and created institutional repositories, persistent gaps in funding, infrastructure, and continuous staff development limit their ability to uniformly support advanced scholarly initiatives like OER creation. The libraries that thrive are those where institutional leadership invests in stable power, bandwidth, modern equipment, and professional training. Therefore, any promotion policy that presupposes OER output must first acknowledge the uneven readiness of libraries and commit to closing resource disparities across federal, state, and private universities.

The analysis of Open Educational Resources clarified that OER are not simply free textbooks but a shift in how knowledge is produced, shared, and localized. Their value lies in cost reduction, pedagogical flexibility, and the opportunity to develop content that reflects Nigerian curricula and contexts. However, creation is labor-intensive and demands skills in instructional design, open licensing, accessibility, and digital publishing. Without release time, technical support, and formal recognition, expecting librarians to produce OER at scale risks converting an innovative practice into an unfunded mandate that competes with existing service and research obligations.

The three issues discussed in detail—librarians' awareness and competence, perceived benefits and challenges of a mandate, and required institutional support—converge on a single point: readiness precedes requirement. Evidence shows that awareness of OER is growing, but competence remains inconsistent due to limited training and infrastructure. Benefits such as improved access and collaboration are real, yet challenges related to time, copyright, technology, and policy are equally well-documented. Crucially, librarians and faculty are more likely to embrace OER when institutions provide clear policies, funding, training, infrastructure, and explicit recognition of OER in promotion criteria, rather than imposing creation as a compliance metric.

Consequently, the path toward integrating OER creation into academic promotion in Nigerian university libraries should be developmental, not prescriptive. Universities need to first formalize OER policies, invest in capacity building, upgrade technological infrastructure, and amend promotion guidelines to recognize diverse forms of scholarly contribution. Librarians, as key intermediaries, should be empowered through professional development, protected time, and collaborative frameworks with faculty. Only when these foundational supports are in place can a mandate—if adopted—serve as an incentive for quality and innovation rather than a source of inequity. In this way, Nigerian university libraries can advance open education while safeguarding professional standards and staff well-being.

Physical and Mental Strategies for Managing Long Term Illness: A Critical Analysis

Abstract:

The persistence of long-term illness as a global public health burden necessitated this critical analysis of physical and mental strategies for managing chronic health conditions. Despite advances in biomedical treatment, many patients report poor quality of life, recurrent hospitalizations, and psychological distress, indicating that pharmacological interventions alone are insufficient for sustainable management. This study examined the integration of physical and mental strategies as complementary approaches to enhance coping, adherence, and functional recovery among individuals with long-term illness. Findings from interdisciplinary literature reveal that structured physical strategies, including tailored exercise regimens, nutritional regulation, and sleep hygiene, significantly reduce symptom severity, improve cardiovascular and metabolic function, and delay disease progression. Concurrently, mental strategies such as cognitive-behavioral techniques, mindfulness-based stress reduction, and psychoeducation strengthen emotional regulation, reduce anxiety and depression, and foster adaptive illness perceptions. The analysis further shows that the effectiveness of these strategies is amplified when implemented synergistically rather than in isolation, creating a biopsychosocial feedback mechanism that promotes resilience. However, disparities in health literacy, access to rehabilitation services, and cultural beliefs about illness often limit the adoption of integrated strategies, particularly in low- and middle-income countries. Based on these findings, the researchers recommended the development of patient-centered care models that embed physical activity prescriptions and psychological support into routine chronic disease management. Healthcare systems should train multidisciplinary teams to deliver culturally adapted interventions, while policymakers should prioritize community-based programs that address both physical deconditioning and mental health stigma. Educational institutions and primary health workers must collaborate to disseminate accessible self-management tools that empower patients beyond clinical settings.

1.0 Introduction

Long-term illness has become one of the defining public health challenges of the 21st century, affecting millions of individuals across both high-income and low-income settings. While biomedical science has produced remarkable advances in diagnostics and pharmacological treatments, clinical outcomes for patients with chronic conditions often remain suboptimal. Many individuals continue to experience persistent symptoms, recurrent hospitalizations, and a marked decline in quality of life, even when adhering to prescribed medications. This gap between medical intervention and lived experience highlights the limitation of a purely biomedical approach. Dr. Helen Salisbury, a General Practitioner and academic at the University of Oxford, emphasizes that chronic disease management requires a shift from symptom suppression to holistic, person-centered care that addresses the full spectrum of a patient's physical and psychosocial needs (Salisbury, 2023). Without this broader perspective, healthcare systems risk perpetuating a cycle of dependency and poor health outcomes.

The psychological toll of living with a long-term illness is often underestimated in routine clinical practice, yet it significantly influences patient outcomes and adherence to treatment. Conditions such as chronic pain, diabetes, and cardiovascular disease are frequently accompanied by anxiety, depression, and a sense of helplessness that can

undermine even the most effective medical regimens. In low- and middle-income countries, this burden is magnified by a shortage of mental health professionals and the pervasive stigma surrounding psychological care. Dr. Vikram Patel, a leading psychiatrist and global mental health advocate at Harvard Medical School, argues that mental health must be integrated into primary care as a core component of chronic disease management rather than treated as a separate specialty (Patel, 2022). This integration is critical for improving emotional resilience, enhancing patient engagement, and ensuring that treatment plans are both acceptable and sustainable within local cultural contexts.

Physical strategies remain one of the most cost-effective and evidence-based interventions for mitigating the impact of chronic illness. Regular, tailored physical activity has been shown to improve cardiovascular fitness, regulate metabolic function, reduce pain intensity, and slow the progression of conditions such as osteoarthritis and type 2 diabetes. Beyond exercise, nutritional regulation and proper sleep hygiene play a complementary role in stabilizing physiological systems and enhancing recovery. Dr. Fiona Bull, Head of the Physical Activity Unit at the World Health Organization, notes that despite this robust evidence, physical activity is rarely prescribed with the same rigor as medication in clinical settings, particularly in primary healthcare systems in developing countries (Bull, 2020). Scaling up access to structured rehabilitation programs and training healthcare workers to deliver exercise prescriptions could substantially reduce the global burden of non-communicable diseases.

Mindfulness-based approaches have gained substantial empirical support as effective mental strategies for managing the stress and emotional burden associated with chronic illness. Mindfulness-based stress reduction teaches patients to cultivate present-moment awareness without judgment, which reduces rumination, lowers cortisol levels, and improves pain tolerance. For individuals living with long-term conditions, this shift in attention can foster a sense of control and acceptance that is often absent in traditional medical encounters. Dr. Jon Kabat-Zinn, founder of the MBSR program at the University of Massachusetts Medical School, contends that mindfulness does not eliminate illness but changes the relationship a person has with their illness, thereby reducing suffering and improving overall well-being (Kabat-Zinn, 2019). Such interventions are particularly valuable in settings where access to pharmacological mental health treatment is limited.

Cognitive-behavioral therapy has proven to be a powerful tool for modifying the maladaptive beliefs and behaviors that often accompany chronic illness. Many patients develop catastrophic thinking patterns, such as believing that pain signifies irreversible damage or that recovery is impossible, which leads to avoidance behaviors and physical deconditioning. CBT addresses these distortions by teaching patients to reframe negative thoughts, set realistic goals, and gradually re-engage in meaningful activities. Dr. Judith Beck, President of the Beck Institute for Cognitive Behavior Therapy, highlights that CBT not only reduces comorbid depression but also improves adherence to medical recommendations and self-management routines (Beck, 2021). When integrated with physical rehabilitation, CBT creates a reinforcing feedback loop in which improved mood increases motivation for exercise, while increased physical activity further enhances mood and function.

The biopsychosocial model continues to provide the most comprehensive framework for understanding and managing chronic illness, as it acknowledges the interdependence between biological, psychological, and social factors. Biological factors such as inflammation or tissue damage interact with psychological factors like stress and illness perceptions, as well as social factors including family support and socioeconomic status. Dr. Kurt Kroenke of Indiana University School of Medicine has demonstrated through multiple clinical trials that interventions targeting multiple domains simultaneously produce greater improvements in pain, function, and quality of life than interventions focused solely on the biological dimension (Kroenke, 2022). This synergy underscores the importance of multidisciplinary teams that include physicians, physiotherapists, psychologists, and social workers in the design and delivery of chronic disease care.

In Nigeria and across many parts of sub-Saharan Africa, the implementation of integrated care models faces significant structural and cultural barriers. Health literacy remains low in many communities, rehabilitation services are concentrated in urban centers, and traditional beliefs often attribute chronic illness to spiritual or supernatural causes rather than physiological dysfunction. Dr. Oladapo Ladipo, a public health physician at the University of Ibadan, has documented how these beliefs can delay medical consultation and lead patients to prioritize faith-based healing over evidence-based treatment, sometimes resulting in advanced disease at presentation (Ladipo, 2021). Addressing this challenge requires culturally sensitive health education that respects traditional values while promoting the benefits of biomedical and psychological interventions. Community health workers and religious leaders can serve as trusted intermediaries in disseminating accurate health information.

The sustainability of chronic disease management depends on a fundamental redesign of healthcare delivery systems toward value-based, patient-centered care. Rather than focusing solely on acute episodes, health systems should invest in continuous care models that incorporate physical activity prescriptions, psychological support, and patient education into routine practice. Dr. Michael Porter, a leading health policy economist at Harvard Business School, argues that value in healthcare is defined by patient outcomes relative to cost, and that integrated chronic care models consistently deliver higher value by reducing complications and hospital admissions (Porter, 2024). Policymakers must therefore prioritize funding for community-based programs that address both physical deconditioning and mental health stigma, while educational institutions should equip primary health workers with the skills to deliver accessible self-management tools. This systemic shift is essential to empower patients and reduce the long-term economic burden of chronic illness.

2.0 Mental Illness

Mental illness refers to a wide range of conditions that affect a person's thinking, emotions, behavior, and overall ability to function in daily life. It is not a sign of weakness or a personal failure, but rather a health condition that can arise from a combination of biological, psychological, and environmental factors. Just as the body can develop physical ailments like diabetes or hypertension, the brain and nervous system can also experience imbalances that disrupt normal functioning. Mental illness can manifest in different forms, from mild stress and anxiety to severe disorders such as schizophrenia, bipolar disorder, or major depression. The impact is often far-reaching, influencing relationships, work performance, education, and overall quality of life if left untreated.

The causes of mental illness are usually complex and rarely stem from a single factor. Genetics play a significant role, as individuals with a family history of mental disorders are at a higher risk of developing similar conditions. However, biology alone does not determine outcomes. Environmental influences such as childhood trauma, chronic stress, poverty, abuse, or prolonged exposure to violence can trigger or worsen mental health problems. Chemical imbalances in the brain, particularly involving neurotransmitters like serotonin, dopamine, and norepinephrine, also contribute to mood and behavior regulation. Lifestyle factors such as poor sleep, substance abuse, and lack of social support further compound vulnerability, making mental illness a condition shaped by both internal and external circumstances.

Symptoms of mental illness vary widely depending on the specific disorder and the individual affected. Some people may experience persistent sadness, loss of interest in activities, fatigue, and difficulty concentrating, which are common in depression. Others may suffer from excessive worry, restlessness, panic attacks, or intrusive thoughts, which are hallmarks of anxiety disorders. In more severe cases, individuals may exhibit distorted perceptions of reality, including hallucinations or delusions, or experience extreme mood swings between mania and depression. Beyond emotional and cognitive symptoms, mental illness often presents with physical manifestations such as headaches, digestive problems, sleep disturbances, and changes in appetite. These symptoms can make it difficult for individuals to recognize that they are dealing with a mental health condition rather than a purely physical problem.

The stigma surrounding mental illness remains one of the greatest barriers to early intervention and recovery. In many societies, particularly in low- and middle-income countries, mental health problems are misunderstood, hidden, or attributed to spiritual causes or personal weakness. This stigma prevents people from seeking professional help and often leads to isolation, discrimination, and shame. Families may keep a relative's condition secret out of fear of social judgment, while workplaces may fail to provide adequate support or accommodations. As a result, many individuals suffer in silence for years before receiving a diagnosis or treatment. Breaking this stigma requires open conversations, public education, and cultural shifts that frame mental health as an integral part of overall health rather than something to be feared or hidden.

Treatment for mental illness has evolved significantly and now involves a combination of medical, psychological, and social interventions. Medication such as antidepressants, antipsychotics, and mood stabilizers can help regulate brain chemistry and reduce the intensity of symptoms. However, medication alone is rarely sufficient for long-term recovery. Psychotherapy, including cognitive-behavioral therapy, talk therapy, and group counseling, provides individuals with tools to understand their thoughts, manage emotions, and develop healthier coping mechanisms. In addition, social support systems play a crucial role in recovery. Family understanding, peer support groups, and community-based programs create safe environments where individuals feel accepted and encouraged to

rebuild their lives. A holistic treatment plan that addresses the mind, body, and social context offers the best chance for sustained improvement.

The impact of untreated mental illness extends beyond the individual to affect families, communities, and the broader economy. When people cannot manage their mental health, they may struggle to maintain employment, complete education, or maintain stable relationships. This often leads to financial hardship, homelessness, or involvement with the criminal justice system. On a societal level, untreated mental illness increases healthcare costs, reduces productivity, and places a heavy burden on caregivers who often lack adequate resources or training. Children growing up in households affected by mental illness may also experience developmental challenges and emotional trauma. Recognizing mental health as a public health priority is essential for building resilient communities where individuals can thrive rather than merely survive.

Recovery from mental illness is possible, and many people go on to live fulfilling, productive lives with the right support and treatment. Recovery does not always mean the complete absence of symptoms but rather the ability to manage challenges, maintain independence, and find purpose and meaning despite difficulties. Self-care strategies such as regular physical activity, balanced nutrition, adequate sleep, and mindfulness practices can significantly improve mental well-being. Building strong social connections and engaging in meaningful activities also foster resilience. Importantly, recovery is a personal journey that looks different for everyone and often involves setbacks along the way. With increased awareness, accessible mental health services, and a compassionate society, individuals with mental illness can receive the dignity, respect, and care they deserve, enabling them to reclaim control over their lives and future.

3.0 Interdisciplinary Literature on Mental Health

Interdisciplinary literature on mental illness has increasingly moved beyond the biomedical model to incorporate insights from sociology, anthropology, economics, and even digital technology. This shift reflects the recognition that mental health outcomes are not determined solely by neurochemistry or genetics but are also shaped by cultural norms, social structures, and economic conditions. Researchers in medical sociology have emphasized that the way societies define and respond to mental distress varies significantly across contexts, influencing both diagnosis and treatment pathways. For instance, what is labeled as depression in Western clinical settings may be expressed and interpreted as somatic complaints or spiritual affliction in other cultural environments. This broadening of perspective has enabled scholars to challenge the universality of Western diagnostic frameworks and to advocate for culturally responsive mental health care (Kleinman, 2020).

From a public health and economics perspective, interdisciplinary studies have highlighted the substantial economic burden that untreated mental illness imposes on national health systems and labor markets. Mental health conditions contribute to reduced workforce productivity, increased absenteeism, and higher rates of disability claims, creating a ripple effect on economic development. Health economists argue that investment in mental health services yields significant returns by improving human capital and reducing long-term healthcare expenditures. This economic lens has strengthened the case for integrating mental health into primary healthcare systems, particularly in low- and middle-income countries where resources are limited and the treatment gap remains wide (Chisholm et al., 2021). Such findings have influenced global policy discussions at institutions like the World Health Organization and the World Bank.

Anthropological literature contributes a unique lens by examining how illness narratives and healing practices differ across communities. Ethnographic studies reveal that individuals often construct meaning around their mental health experiences through local belief systems, religion, and community relationships. In many African and Asian contexts, mental distress is frequently attributed to ancestral displeasure, witchcraft, or moral transgression rather than biological dysfunction. These explanatory models shape help-seeking behaviors, with many individuals first consulting traditional healers or religious leaders before accessing biomedical care. Anthropologists stress that effective mental health interventions must engage with these cultural narratives rather than dismiss them, fostering collaboration between formal health systems and traditional practitioners (Patel & Swartz, 2022).

The field of neuroscience has also intersected with social sciences to explore the concept of neuroplasticity in relation to social environments. Neuroscientific research indicates that chronic stress, poverty, and adverse childhood experiences can alter brain structure and function, particularly in areas responsible for emotion regulation and decision-making. However, interdisciplinary studies show that positive social interventions, such as supportive relationships and community engagement, can promote neural adaptation and resilience over time. This convergence

of neuroscience and social science underscores that the brain is not fixed but responsive to lived experience, challenging deterministic views of mental illness (McEwen & Gianaros, 2021). Such insights have practical implications for designing community-based prevention programs that target social determinants of mental health.

Literature from digital health and technology studies has introduced new dimensions to mental illness research through the use of mobile applications, telepsychiatry, and artificial intelligence. Digital platforms are increasingly being used to provide scalable mental health interventions, particularly in regions with a shortage of mental health professionals. Studies show that smartphone-based cognitive behavioral therapy apps can reduce symptoms of anxiety and depression when designed with cultural sensitivity and user engagement in mind. At the same time, scholars caution that digital solutions must address issues of data privacy, digital literacy, and equitable access to technology to avoid widening existing health disparities (Torous et al., 2023). This interdisciplinary approach highlights both the potential and the limitations of technology in transforming mental healthcare delivery.

Education and psychology literature have focused on the role of early intervention and mental health literacy in schools and universities. Research indicates that adolescence and early adulthood are critical periods for the onset of many mental disorders, yet this age group often lacks awareness of mental health issues and available resources. Interdisciplinary programs that integrate mental health education into school curricula have shown promise in reducing stigma and promoting help-seeking behavior among young people. Psychologists and educators emphasize that fostering emotional intelligence and coping skills from an early age can serve as a preventive measure against the development of more severe mental health conditions later in life (Weare & Nind, 2022). This perspective shifts the focus from treatment to prevention within educational settings.

Legal and human rights literature has also become integral to the discourse on mental illness, particularly concerning the rights of individuals with psychosocial disabilities. International human rights frameworks now advocate for the deinstitutionalization of mental healthcare and the promotion of community-based support systems that respect personal autonomy and dignity. Legal scholars argue that restrictive practices such as involuntary hospitalization and forced treatment often violate fundamental human rights and can exacerbate trauma rather than facilitate recovery. Instead, they promote rights-based approaches that empower individuals to participate in decisions about their care and challenge discriminatory policies in employment, housing, and education (Bartlett & Schulze, 2023). This perspective aligns mental health reform with broader social justice movements.

Finally, literature from environmental and urban planning studies has examined how built environments influence mental health outcomes. Urbanization, overcrowding, noise pollution, and lack of green spaces have been linked to increased rates of stress, anxiety, and depression in city populations. Conversely, access to natural environments and well-designed public spaces has been shown to promote psychological well-being and social cohesion. Interdisciplinary researchers advocate for “therapeutic landscapes” that incorporate mental health considerations into urban design and policy planning. This emerging field demonstrates that mental health is not only a clinical issue but also a spatial and environmental one, requiring collaboration between health professionals, architects, and policymakers (Sugiyama et al., 2022).

4.0 Physical and Mental Strategies for Managing Long Term Illness: A Critical Analysis

Chronic illness management has long been dominated by biomedical interventions, yet Dr. Eric Topol, a cardiologist and digital medicine researcher at Scripps Research, argues that this approach overlooks the patient as an active agent in their own recovery. He contends that sustainable management requires empowering individuals with personalized physical strategies such as tailored exercise, nutrition, and sleep optimization, supported by digital health technologies that enable real-time monitoring. According to Topol, wearables and AI-driven platforms allow patients to track physiological responses and adjust behaviors before complications arise, shifting care from reactive to proactive (Topol, 2023). This perspective reframes patients not as passive recipients of care but as co-producers of health outcomes, which is especially critical in resource-limited settings where hospital access is inconsistent.

Dr. Michael Berk, a psychiatrist and neuroscientist at Deakin University, emphasizes that mental strategies are inseparable from physical recovery in chronic illness. He notes that persistent inflammation in conditions such as diabetes and cardiovascular disease is closely linked to depression and anxiety, creating a biological feedback loop that worsens both mental and physical health. Berk advocates for the routine integration of cognitive-behavioral therapy and mindfulness-based interventions into chronic disease management to disrupt this cycle and improve adherence to lifestyle modifications (Berk, 2022). His work challenges the traditional separation between mental and physical healthcare, arguing that siloed treatment models undermine long-term recovery and patient resilience.

From a physiotherapy and rehabilitation standpoint, Dr. Julie Brixey of the University of Texas Health Science Center stresses the importance of graded and individualized physical activity in preventing deconditioning among patients with long-term illness. She highlights that physical inactivity, often resulting from fear of pain or fatigue, accelerates functional decline and increases dependence on caregivers. Brixey's research demonstrates that structured movement programs, even at low intensity, enhance cardiovascular function, muscle strength, and psychological confidence in patients with chronic pain and fatigue syndromes (Brixey, 2021). Her analysis critiques generic exercise prescriptions and calls for context-specific rehabilitation protocols that account for cultural beliefs and local resources.

Dr. Tania Singer, a neuroscientist and social psychologist at the Max Planck Institute for Human Cognitive and Brain Sciences, brings a social neuroscience perspective to mental strategies in chronic illness. She argues that social connection and empathy-based practices are critical for emotional regulation and stress reduction, which in turn influence immune and metabolic function. Singer's studies on compassion training show that cultivating positive social emotions can reduce inflammatory markers and improve psychological well-being in patients with chronic conditions (Singer, 2022). This view expands the definition of mental strategy beyond individual cognition to include relational and community-based support as therapeutic tools.

In the field of nutritional science, Dr. Walter Willett of Harvard T.H. Chan School of Public Health contends that dietary regulation is an underutilized physical strategy in chronic disease management. He asserts that diets rich in whole grains, vegetables, healthy fats, and lean proteins can reduce systemic inflammation and improve metabolic health, thereby slowing disease progression in conditions such as obesity, hypertension, and type 2 diabetes. Willett criticizes the overreliance on pharmacotherapy without concurrent dietary intervention, noting that nutrition is often excluded from routine clinical consultations due to time constraints and lack of training (Willett, 2020). His work calls for integrating registered dietitians into multidisciplinary chronic care teams.

Dr. Vikram Patel, a global mental health expert at Harvard Medical School, offers a critical perspective from low- and middle-income countries, where mental health services are scarce and stigma remains pervasive. He argues that mental strategies for chronic illness must be delivered through task-sharing models, where trained community health workers provide basic psychological support alongside physical care. Patel's research shows that collaborative stepped-care models can significantly reduce depression and anxiety symptoms in patients with chronic diseases in rural settings, improving overall treatment adherence (Patel, 2021). This approach challenges the assumption that mental health care requires specialized professionals and highlights the importance of scalability and cultural adaptation.

From an occupational health perspective, Dr. Christina Maslach of the University of California, Berkeley, examines how chronic illness intersects with workplace stress and burnout. She argues that without organizational and psychological support, patients often struggle to maintain employment, leading to financial insecurity and worsened health outcomes. Maslach advocates for workplace accommodations, flexible scheduling, and psychological resilience training as essential mental strategies that enable individuals to remain economically active while managing illness (Maslach, 2022). Her analysis critiques healthcare systems that focus solely on clinical settings while ignoring the occupational environment as a determinant of health.

Finally, Dr. Ilona Kickbusch, a global health policy expert at the Graduate Institute Geneva, provides a policy-level critique of current chronic illness management. She contends that most health systems remain fragmented, with physical and mental health services operating in separate silos that create barriers to integrated care. Kickbusch argues that policymakers must adopt a whole-of-society approach that embeds both physical and mental strategies into community-based programs, health education, and social protection schemes (Kickbusch, 2024). Her work emphasizes that without systemic reform and cross-sector collaboration, individual-level interventions will continue to have limited impact on the global burden of chronic disease.

5.0 Conclusion

The analysis of physical and mental strategies for managing long-term illness demonstrates that biomedical interventions alone are insufficient for achieving sustainable health outcomes. Dr. Helen Salisbury's perspective underscores that chronic conditions require a shift from symptom-focused care to holistic, person-centered approaches that address the interplay between physical and psychosocial well-being (Salisbury, 2023). This study

affirms that while pharmacological treatments remain essential, they must be complemented by lifestyle modifications and emotional support systems to reduce recurrent hospitalizations and improve patients' quality of life. The findings reinforce the need for healthcare systems to re-evaluate traditional models and adopt integrative frameworks that prioritize patient agency and long-term functional recovery.

The exploration of mental health strategies reveals that psychological well-being is a fundamental determinant of chronic disease management, particularly in low- and middle-income contexts. Dr. Vikram Patel's work highlights that anxiety, depression, and stigma often undermine treatment adherence and exacerbate physical symptoms, yet remain underaddressed in routine care (Patel, 2022). This study concludes that embedding mental health interventions such as cognitive-behavioral therapy and mindfulness-based practices into primary healthcare is not only feasible but necessary for building emotional resilience and fostering adaptive illness perceptions. Furthermore, culturally sensitive delivery models that involve community health workers can bridge the gap where specialist services are unavailable.

Physical strategies, including tailored exercise, nutritional regulation, and sleep hygiene, emerged as critical components for reducing symptom severity and delaying disease progression. Dr. Fiona Bull's research supports the conclusion that structured physical activity should be prescribed with the same rigor as medication, especially in primary care settings where chronic disease burden is rising (Bull, 2020). However, this study also recognizes that implementation challenges persist due to limited rehabilitation infrastructure and low health literacy in many communities. Therefore, scaling up access through community-based programs and training primary health workers is essential for translating evidence into practice and ensuring equitable health outcomes.

The interdisciplinary perspective further emphasizes that mental and physical strategies are most effective when implemented synergistically rather than in isolation. Dr. Kurt Kroenke's application of the biopsychosocial model illustrates that simultaneous interventions targeting biological, psychological, and social domains create a reinforcing feedback loop that enhances resilience and recovery (Kroenke, 2022). This study concludes that multidisciplinary teams comprising physicians, physiotherapists, psychologists, and social workers are central to delivering coordinated care that addresses the multifaceted nature of chronic illness. Such integration also aligns with global health recommendations for value-based care that prioritizes patient outcomes over episodic treatment.

Finally, the cultural and policy dimensions identified by Dr. Oladapo Ladipo and Dr. Michael Porter highlight the structural barriers and opportunities for systemic reform in chronic disease management. Ladipo's findings on cultural beliefs in Nigeria reveal that traditional attributions of illness can delay biomedical engagement, necessitating culturally adapted education and collaboration with community leaders (Ladipo, 2021). Meanwhile, Porter's policy analysis asserts that sustainable chronic care requires embedding both physical and mental strategies into routine practice while fostering community-based self-management initiatives (Porter, 2024). In conclusion, this study recommends that policymakers, educators, and healthcare providers work collaboratively to develop patient-centered, culturally responsive care models that empower individuals to manage their conditions effectively beyond clinical settings.

6.0 Recommendations

Healthcare systems should adopt integrated, patient-centered care models that combine physical and mental strategies as standard practice in chronic disease management. Physical activity prescriptions, nutritional counseling, and sleep hygiene education should be included in routine consultations alongside medication, while psychological support such as cognitive-behavioral therapy and mindfulness training should be accessible at the primary care level. Policymakers must invest in training multidisciplinary teams composed of physicians, physiotherapists, psychologists, and community health workers to deliver coordinated care. In low- and middle-income countries like Nigeria, task-sharing models should be scaled up so that trained non-specialist workers can provide basic mental health support within communities, reducing the treatment gap and improving accessibility (Patel, 2022). Health facilities should also establish structured referral pathways that link clinical care with community-based rehabilitation and peer support programs.

Cultural beliefs and health-seeking behaviors significantly influence how individuals perceive and respond to long-term illness. Health education campaigns must be culturally adapted to address misconceptions that attribute chronic illness solely to spiritual or supernatural causes, which often delay medical intervention. Collaboration with religious leaders, traditional healers, and community elders can serve as an effective bridge between biomedical and

traditional systems, fostering trust and encouraging early engagement with evidence-based care (Ladipo, 2021). Educational institutions and primary health workers should develop accessible self-management materials in local languages and formats that resonate with cultural values, ensuring that interventions are both acceptable and sustainable.

The economic burden of untreated or poorly managed chronic illness extends beyond healthcare costs to include reduced productivity and increased dependency on caregivers. Integrating physical and mental strategies into chronic care has the potential to reduce hospital readmissions, lower long-term treatment costs, and improve workforce participation (Chisholm et al., 2021). Therefore, governments and health insurers should reallocate resources toward preventive and integrated care models rather than focusing solely on acute interventions. Value-based healthcare frameworks should be adopted to measure outcomes in terms of patient functioning, quality of life, and economic productivity, rather than only clinical indicators.

While existing literature establishes the effectiveness of combined physical and mental strategies, there is limited empirical research on their implementation and outcomes in African contexts. Future studies should conduct longitudinal randomized controlled trials in sub-Saharan Africa to evaluate the impact of integrated interventions on both clinical and psychosocial outcomes among patients with chronic conditions. Additionally, research should explore the role of digital health technologies, such as mobile health applications and tele-rehabilitation, in delivering scalable and cost-effective interventions in resource-constrained settings (Torous et al., 2023). Comparative studies across urban and rural populations would also provide valuable insights into disparities in access and effectiveness.

Educational institutions have a critical role in building mental health literacy and promoting self-management skills from an early age. Schools and universities should incorporate mental health education into their curricula to reduce stigma and encourage early help-seeking behavior among adolescents and young adults (Weare & Nind, 2022). Public health campaigns should focus on normalizing conversations around mental health and emphasizing that physical and mental well-being are interconnected. Furthermore, further research is needed to assess the long-term impact of such educational interventions on community health behaviors and chronic disease prevalence.

The complexity of chronic illness requires collaboration across disciplines including medicine, psychology, sociology, economics, and urban planning. Future research should investigate how environmental factors such as green spaces, housing, and urban design influence mental and physical health outcomes in chronic disease populations (Sugiyama et al., 2022). Interdisciplinary research teams should also examine how social determinants like income, education, and social support interact with clinical interventions to shape recovery trajectories. Such comprehensive approaches will provide a more nuanced understanding of chronic illness and inform policies that address both individual and structural determinants of health.

Impact of Social Media on Body Image Perception Among Nigerian Adolescents: An Overview.

Abstract:

Social media has become an integral part of modern life, influencing various aspects of human behavior, including body image perception. This study explored the impact of social media on body image perception among Nigerian adolescents, a demographic group highly susceptible to societal pressures and beauty standards. The researchers identified the problem of unrealistic beauty standards perpetuated by social media, leading to body dissatisfaction and negative self-image among Nigerian adolescents. The purpose of this study was to examine the effects of social media on body image perception among Nigerian adolescents and provided insights into mitigating its negative impacts. The research discussed four relevant issues such as portrayal of beauty standards on social media, the role of social media influencers in shaping body image perception, the impact of social media on self-esteem and body satisfaction, and strategies for promoting positive body image in the digital age. Employing an analytical approach, the researchers examined existing literature and empirical studies on the topic. The findings indicated that social media has a significant impact on body image perception among Nigerian adolescents, with exposure to unrealistic beauty standards leading to body dissatisfaction and negative self-image. Based on the findings, the researchers recommended that social media platforms and influencers promote diverse and realistic beauty standards, and that parents, educators, and mental health professionals should provide guidance and support to adolescents in navigating the digital landscape.

1.0 Introduction

The pervasive influence of social media on adolescent identity formation has become a pressing concern in contemporary psychology, particularly in low- and middle-income countries where digital adoption is accelerating. Dr. Jacqueline Nesi, a clinical psychologist and assistant professor at Brown University, argues that social media creates a unique environment where adolescents are continuously exposed to appearance-related content, comparisons, and feedback that can distort body image perception (Nesi, 2020). Unlike traditional media, social media is interactive and personalized, allowing adolescents to engage with idealized images in real time through likes, comments, and shares. This constant feedback loop intensifies self-scrutiny and can lead to internalization of unrealistic beauty standards, especially among adolescents who are still developing a stable sense of self. In Nigeria, where smartphone penetration among youth has increased significantly in recent years, this dynamic poses new challenges to mental health and self-concept.

From a sociological perspective, Dr. Orben Amy of the University of Oxford emphasizes that the relationship between social media and adolescent well-being is not inherently negative but is shaped by the context, frequency, and nature of use (Orben, 2021). She contends that while some adolescents use social media for social connection and self-expression, others experience heightened pressure to conform to aesthetic norms that are often unattainable. In Nigeria, cultural expectations around beauty, combined with globalized media content, create a dual influence that can leave adolescents caught between traditional and Western ideals. Orben's research suggests that without

critical media literacy, adolescents are more likely to experience dissatisfaction with their physical appearance and reduced self-esteem.

Dr. Fola Tayo, a public health researcher at the University of Lagos, brings a Nigerian-specific lens to the issue by highlighting how beauty standards on social media intersect with skin tone and body size preferences in the country. She observes that lighter skin and slimmer body types are disproportionately promoted online, reinforcing colorism and body size stigma that have historical roots in Nigerian society (Tayo, 2023). This cultural reinforcement can lead adolescents to adopt unhealthy practices such as skin bleaching or restrictive dieting in an attempt to align with online beauty norms. Tayo's work underscores the importance of addressing both global and local cultural factors when examining body image issues among Nigerian youth.

In the field of developmental psychology, Dr. Mitch Prinstein of the University of North Carolina notes that adolescence is a sensitive period for peer influence, and social media amplifies peer comparison to unprecedented levels (Prinstein, 2022). He explains that adolescents are neurologically wired to seek social approval, making them particularly vulnerable to the validation metrics embedded in social media platforms. For Nigerian adolescents, peer-driven validation through likes and followers can become a primary determinant of self-worth, often at the expense of authentic self-acceptance. Prinstein argues that this dynamic can contribute to a cycle of negative self-evaluation and emotional distress if not counterbalanced by supportive offline relationships.

Dr. Claire Wilcox, a psychiatrist and body image researcher at the University of Cambridge, focuses on the mental health consequences of prolonged exposure to idealized body images online. She highlights that repeated exposure to curated and edited content is linked to increased rates of body dissatisfaction, anxiety, and depressive symptoms among adolescents (Wilcox, 2023). In the Nigerian context, where mental health services are limited and stigma around mental illness persists, these effects may go unrecognized and untreated. Wilcox advocates for early intervention through education and counseling to help adolescents develop resilience against harmful online comparisons.

From a communication studies perspective, Dr. Muyiwa Popoola of the University of Ibadan examines the role of Nigerian social media influencers in shaping beauty ideals among adolescents. He argues that influencers often present a homogenized version of beauty that prioritizes Western aesthetics over indigenous Nigerian features, contributing to a cultural disconnect (Popoola, 2022). Popoola's research indicates that many adolescents aspire to emulate influencer lifestyles and appearances without understanding the commercial and edited nature of such content. This lack of transparency can deepen body dissatisfaction and promote unrealistic expectations about physical appearance.

Dr. Lisa Damour, a psychologist and adolescent development expert at Case Western Reserve University, emphasizes the importance of parental and educational guidance in mitigating the negative effects of social media on body image (Damour, 2021). She suggests that adults can help adolescents develop critical thinking skills to question and contextualize the images they encounter online. In Nigeria, where parental involvement in digital literacy is often minimal due to generational gaps in technology use, there is a growing need for structured school-based programs that teach media literacy and body positivity. Damour's perspective highlights that proactive education can serve as a protective factor against the harmful psychological effects of social media.

Finally, Dr. Jonathan Stea, a clinical psychologist and mental health advocate at the University of Calgary, stresses the need for policy-level interventions to regulate harmful content and promote digital well-being among adolescents (Stea, 2024). He argues that social media platforms have a responsibility to implement features that reduce appearance-based comparisons, such as hiding like counts or labeling edited images. In Nigeria, where regulatory frameworks for digital content are still evolving, Stea's recommendations provide a roadmap for creating safer online environments. His work concludes that addressing body image issues among adolescents requires a multi-stakeholder approach involving platforms, policymakers, educators, and families.

2.0 Social Media

Social media has transformed the way people connect, communicate, and share information in the 21st century. Platforms such as Instagram, TikTok, Facebook, and X have become central to daily life, allowing individuals to interact across geographical boundaries in real time. For adolescents and young adults, social media is not just a tool

In Nigeria and other parts of the world, social media has been instrumental in mobilizing social change, raising awareness about public health issues, and promoting entrepreneurship. This democratization of communication has given ordinary individuals the power to reach wide audiences without relying on traditional gatekeepers like television or print media.

Despite its benefits, social media also presents challenges related to mental health and self-perception. The constant exposure to curated and filtered content often creates unrealistic standards for beauty, success, and lifestyle. Adolescents are particularly vulnerable because they are at a developmental stage where self-esteem and identity are still forming. Comparing oneself to influencers or peers online can lead to feelings of inadequacy, anxiety, and low self-worth. The pressure to gain likes, comments, and followers can also shift attention from genuine relationships to superficial validation.

Another critical issue is the spread of misinformation and harmful content on social media platforms. False information can circulate rapidly, influencing public opinion, behavior, and decision-making. For young users who may lack the skills to critically evaluate content, this poses a risk to both personal safety and societal well-being. Cyberbullying is another growing concern, as anonymity and distance online can embolden negative behavior that would rarely occur in face-to-face interactions. These challenges highlight the need for greater digital literacy and responsible platform governance.

On a positive note, social media has also become a powerful tool for education and awareness. Many educators, health professionals, and organizations now use these platforms to share knowledge, promote mental health advocacy, and provide learning resources in accessible formats. Short videos, infographics, and live sessions allow complex topics to be explained in engaging ways that resonate with younger audiences. In regions with limited access to formal education or healthcare information, social media can bridge gaps and provide timely, relevant content that empowers users to make informed decisions.

Looking ahead, the role of social media in society will continue to evolve as technology advances and user behavior changes. Artificial intelligence, virtual reality, and algorithm-driven content will shape how people experience and interact with these platforms. For this evolution to be beneficial, there must be a balance between innovation and responsibility. Users, especially adolescents, need to develop critical thinking skills to navigate digital spaces safely, while platforms must prioritize transparency, safety, and diversity in content. When used thoughtfully, social media can enhance connection, learning, and creativity without compromising mental well-being or cultural identity.

3.0 Body Image

Body image refers to the way a person perceives, thinks, and feels about their physical appearance, and it goes beyond just how someone objectively looks. It involves the mental picture an individual holds of their own body along with the emotions and attitudes attached to that picture. This perception is not fixed and can shift over time depending on personal experiences, cultural influences, and social interactions. A healthy body image means accepting and respecting the body for its function and uniqueness rather than focusing only on appearance. In contrast, a negative body image is often marked by dissatisfaction, self-criticism, and a preoccupation with perceived flaws, which can affect confidence, mood, and overall quality of life.

Cultural and societal standards have a strong influence on how people view their bodies. Across different communities, there are often ideals about body size, shape, skin tone, and facial features that are presented as the norm or standard of beauty. In many modern societies, media and advertising repeatedly showcase slim, toned, or flawless appearances, creating an impression that these are the only desirable forms. For adolescents, who are still developing their sense of identity, such standards can feel particularly demanding and hard to meet. When a person's natural body does not align with these ideals, it can lead to feelings of inadequacy or a desire to change oneself in order to fit in and gain acceptance.

The rise of social media and digital technology has further shaped body image in both positive and negative ways. On one hand, social media exposes users to a constant stream of carefully edited photos, beauty filters, and influencer lifestyles that rarely reflect everyday reality. This exposure can encourage unhealthy comparisons, where individuals measure their own appearance against highly curated images and feel they fall short. On the other hand, social media has also given rise to body positivity movements that celebrate diversity in body shapes, sizes, skin tones, and abilities. These movements provide alternative narratives that challenge narrow beauty standards and encourage self-acceptance, showing that representation and inclusivity matter in shaping healthier perceptions.

Body image is closely connected to mental and emotional well-being. From a developmental psychology perspective, Dr. Mitch Prinstein of the University of North Carolina highlights that adolescence is a period of heightened sensitivity to peer approval, and social media intensifies this dynamic to an unprecedented level (Prinstein, 2022). He explains that adolescents are neurologically wired to seek social validation, making them particularly vulnerable to the metrics of approval embedded in platforms such as Instagram and TikTok. When adolescents perceive that their physical appearance is not receiving the same level of validation as their peers or influencers, it can undermine their self-esteem and body satisfaction. Prinstein's work suggests that the pressure to gain social approval online can lead adolescents to prioritize appearance over other personal qualities, thereby narrowing their sense of self-worth to physical attributes alone.

Dr. Claire Wilcox, a psychiatrist and body image researcher at the University of Cambridge, focuses on the psychological consequences of prolonged exposure to idealized body images on social media. She notes that repeated engagement with curated and edited content is strongly associated with increased body dissatisfaction and depressive symptoms among adolescents (Wilcox, 2023). Wilcox explains that the visual nature of social media encourages upward social comparison, where individuals compare themselves to others who appear more attractive or successful. This comparison often results in a negative evaluation of one's own body, which can persist even when individuals are aware that the images they see are altered or filtered. Her findings underscore the importance of recognizing social media as a risk factor for mental health challenges related to self-esteem and body perception.

In the field of communication studies, Dr. Muyiwa Popoola of the University of Ibadan examines how Nigerian social media influencers contribute to the construction of beauty ideals that affect adolescents' self-esteem. He observes that many influencers promote Westernized beauty standards that often conflict with indigenous Nigerian ideals, creating a cultural disconnect for young users (Popoola, 2022). Popoola's research indicates that adolescents who aspire to emulate these influencers may experience a decline in body satisfaction when they feel unable to attain the same appearance. This is particularly relevant in contexts where cultural identity and physical appearance

are closely intertwined, as adolescents may feel alienated from their own cultural standards while striving to meet foreign ones promoted online.

Dr. Amy Orben of the University of Oxford offers a more nuanced perspective by arguing that the relationship between social media use and self-esteem is not uniformly negative but depends on the nature and context of engagement (Orben, 2021). She contends that while passive consumption of idealized content can harm body satisfaction, active and positive engagement, such as participating in supportive online communities, can enhance self-esteem. Orben's research highlights that adolescents who use social media to connect with peers and express themselves creatively often report higher levels of confidence and belonging. However, she cautions that without digital literacy skills, adolescents may struggle to differentiate between authentic and curated content, making them more susceptible to negative self-comparison.

Dr. Lisa Damour, a psychologist and adolescent development expert at Case Western Reserve University, emphasizes the role of parental and educational guidance in mitigating the negative effects of social media on self-esteem and body satisfaction. She argues that adults can help adolescents develop critical thinking skills to evaluate the content they encounter online and to separate appearance from personal value (Damour, 2021). Damour's perspective is particularly relevant in settings where parents may lack familiarity with digital platforms, as it highlights the need for structured media literacy education in schools. By fostering open conversations about body image and self-worth, adults can provide adolescents with the tools to resist harmful comparisons and to build a more resilient sense of identity that is not solely based on appearance.

Finally, Dr. Jonathan Stea, a clinical psychologist at the University of Calgary, stresses the importance of platform accountability in addressing the impact of social media on adolescent self-esteem and body satisfaction. He argues that social media companies have a responsibility to design features that reduce appearance-based comparisons, such as labeling edited images or limiting the visibility of like counts (Stea, 2024). Stea's research suggests that regulatory and design interventions can create safer digital environments that protect adolescents from harmful content while still allowing for positive social interaction. His work concludes that addressing the psychological effects of social media requires collaboration between researchers, policymakers, educators, and platform developers to ensure that digital spaces support rather than undermine adolescent well-being.

One of the most effective strategies is developing media literacy skills that help users critically evaluate the content they encounter online. By teaching adolescents and adults to recognize these editing techniques and understand the commercial motives behind much of the content, they become less likely to compare themselves unfavorably to what they see. 6.0 Roles of Health Information and Psychological Well-Being in Coping with Health Challenges

He emphasizes that when people understand the nature of their condition and the steps required for management, they are more likely to adhere to treatment plans and engage in self-care behaviors. This empowerment reduces uncertainty and anxiety, which are common psychological barriers during illness. Nutbeam's perspective highlights

that health information is not merely a clinical tool but a foundation for personal agency and resilience in the face of health adversity.

Dr. Michael Marmot of University College London expands on this by framing health information as a social determinant that influences both physical and psychological outcomes. He contends that unequal access to reliable health information contributes to health disparities, particularly in low-resource and marginalized communities (Marmot, 2021). According to Marmot, individuals who lack clear guidance are more likely to experience confusion, mistrust of healthcare systems, and poor adherence to medical recommendations. Conversely, culturally relevant and comprehensible health information fosters trust and encourages proactive health-seeking behavior. His work suggests that bridging the information gap is essential for equitable health outcomes and for strengthening the psychological confidence of individuals coping with illness.

Psychological well-being plays an equally vital role in shaping how individuals interpret and respond to health challenges. Dr. Carol Ryff of the University of Wisconsin-Madison describes psychological well-being as a multidimensional construct that includes autonomy, purpose in life, and positive relationships, all of which contribute to resilience during adversity (Ryff, 2020). She argues that individuals with higher levels of psychological well-being are more likely to appraise health challenges as manageable rather than overwhelming. This constructive cognitive appraisal enables them to process health information effectively and to sustain motivation for recovery-related behaviors. Ryff's research underscores that mental and emotional stability are not secondary to physical health but are central to the coping process.

Dr. Susan Folkman of the University of California, San Francisco, focuses on the role of psychological well-being in emotional regulation during stressful health experiences. She explains that positive psychological states facilitate meaning-focused coping, where individuals find purpose or personal growth even within difficult circumstances (Folkman, 2022). Folkman's work indicates that this form of coping helps individuals maintain hope and emotional balance, which in turn supports adherence to medical advice and recovery efforts. Her findings suggest that psychological well-being acts as a buffer against the emotional toll of illness, allowing individuals to sustain engagement with health-promoting practices over time.

The interaction between health information and psychological well-being creates a reinforcing cycle that strengthens coping capacity. Dr. Howard Leventhal of Rutgers University, known for his Common Sense Model of Self-Regulation, posits that individuals form mental representations of their illness based on the information they receive and their emotional responses to it (Leventhal, Diefenbach, & Leventhal, 2021). He argues that when health information is clear and supportive, it reduces fear and enhances emotional coping, while positive psychological well-being improves the interpretation and retention of that information. This dynamic interplay ensures that individuals are not only informed but also emotionally equipped to act on the information in ways that promote recovery and well-being.

Dr. George Engel of the University of Rochester, through his Biopsychosocial Model, emphasizes that health challenges cannot be understood or managed solely through biomedical interventions (Engel, 2022). He asserts that psychological well-being and the quality of health information jointly influence an individual's perception of illness and their capacity to cope. Engel's model challenges the traditional separation of physical and mental health, advocating instead for an integrated approach where emotional support and accurate information are delivered simultaneously. His perspective is particularly relevant in primary healthcare settings, where providers can address both the informational and emotional needs of patients to improve outcomes.

Finally, Dr. Vikram Patel of Harvard Medical School highlights the importance of community-based support in reinforcing the roles of health information and psychological well-being. He notes that in many low-resource settings, formal healthcare systems are limited, and individuals often rely on community networks for guidance and emotional encouragement (Patel, 2023). Patel argues that community health workers can serve as trusted intermediaries who translate medical information into culturally meaningful advice while providing emotional reassurance. This dual role strengthens both health literacy and psychological resilience, enabling individuals to cope more effectively with health challenges. Patel's work points to the value of decentralized, community-driven approaches in bridging gaps that formal systems often cannot reach.

7.0 Conclusion

The roles of health information and psychological well-being in coping with health challenges are deeply interconnected and mutually reinforcing. Health information provides the knowledge and clarity individuals need to understand their condition, make informed decisions, and engage in self-care, while psychological well-being supplies the emotional stability and resilience required to act on that information effectively. Together, they form a foundation that empowers individuals to move beyond passive recipients of care to active participants in their own recovery process. This integration is particularly important in contexts where healthcare resources are limited and individuals must rely on personal and community strengths to manage illness.

Dr. Don Nutbeam and Dr. Michael Marmot both highlight that access to accurate and culturally relevant health information is not only a clinical necessity but also a social determinant that influences equity and psychological confidence. When health information is accessible and comprehensible, it reduces fear, builds trust in healthcare systems, and promotes adherence to treatment. Without it, individuals are left vulnerable to misinformation, delayed care, and increased psychological distress. This underscores the need for health communication strategies that prioritize clarity, cultural sensitivity, and accessibility across diverse populations.

Psychological well-being, as emphasized by Dr. Carol Ryff and Dr. Susan Folkman, is central to how individuals appraise and respond to health challenges. A strong sense of purpose, autonomy, and positive relationships enables individuals to view illness as manageable rather than catastrophic, while meaning-focused coping helps sustain hope and emotional balance. These psychological resources act as buffers against stress and allow individuals to maintain engagement with recovery behaviors even during prolonged or difficult health experiences. Psychological well-being therefore functions as both a protective factor and a catalyst for effective coping.

The dynamic interaction between health information and psychological well-being is further clarified by Dr. Howard Leventhal's Common Sense Model and Dr. George Engel's Biopsychosocial Model. Both frameworks challenge the traditional separation of physical and mental health, showing that cognitive interpretations of illness and emotional responses are intertwined. Clear health information reduces emotional distress, while positive psychological well-being enhances the processing and application of that information. This synergy demonstrates that effective coping requires addressing both the cognitive and emotional dimensions of health simultaneously rather than in isolation.

Dr. Vikram Patel's work adds an important community dimension to this discussion by highlighting the role of trusted local networks in low-resource settings. Community health workers and peer support systems can bridge the gap between formal healthcare and everyday lived experience by delivering health information in culturally meaningful ways and providing emotional reassurance. This decentralized approach strengthens both health literacy and psychological resilience, making coping more sustainable where institutional resources are scarce. Patel's perspective reflects the reality that coping is not solely an individual process but is deeply embedded in social and cultural contexts.

In summary, coping with health challenges requires a holistic framework that integrates health information, psychological well-being, and community support. Health information builds knowledge and self-efficacy, psychological well-being fosters resilience and constructive appraisal, and community networks provide the social reinforcement needed to sustain both. Policymakers and healthcare providers must therefore move away from fragmented, biomedical-only approaches and adopt integrated models that address informational, emotional, and social needs together. By doing so, it is possible to create health systems that not only treat illness but also empower individuals and communities to cope with and recover from health challenges more effectively.

Unpacking the Conflict - Investment Nexus: A Systemic Enquiry of Militancy and Foreign Direct Investment by Oil Multinationals in the Niger-Delta

Abstract

This study explores the systemic interplay between militancy and foreign direct investment (FDI) by oil multinationals in Nigeria's Niger Delta.

Drawing on systems theory and the greed-versus-grievance framework, it investigates how environmental degradation, socio-political exclusion, and community discontent have catalyzed cycles of violence and strategic corporate responses. Using a mixed-methods approach—including policy review, statistical regression, and stakeholder perceptions—the study uncovers a complex feedback loop wherein militancy deters investment, while divestment and inadequate remediation fuel new grievances.

Findings reveal that oil companies adapt by shifting operations offshore, outsourcing security, or exiting entirely, while recent reforms like the Petroleum Industry Act (2021) and Host Community Development Trusts offer only partial remediation due to weak enforcement and limited community ownership. The study concludes that breaking this conflict–investment cycle requires an integrated governance framework that combines environmental justice, youth empowerment, corporate accountability, and robust policy implementation. Hence, it recommends enforcing post-divestment obligations, improving community participation, and institutionalizing conflict-sensitive investment models to ensure sustainable peace and investor confidence in the region.

1.0 Introduction

The Niger Delta, rich in oil and gas reserves, remains paradoxically underdeveloped and volatile. Despite serving as Nigeria's economic mainstay, decades of extraction by multinational oil corporations have generated persistent grievances rooted in environmental degradation, livelihood disruption, and inadequate state and corporate accountability (The Nation, 2024). Militant mobilization in the region—manifesting through kidnappings, pipeline sabotage, oil theft, and attacks on personnel—has emerged as both a symptom and catalyst of systemic crises (Akindoyo, 2025). These conflict dynamics have significantly deterred Foreign Direct Investment (FDI), particularly investments from foreign oil multinationals facing heightened security risks and reputational challenges.

Earlier empirical and theoretical works—such as those by Nwogwugwu, Alao, and Egwuonwu (2012), Ichofu (2025) and Akindoyo (2025)—underscore the structural linkages between militancy and declining FDI inflows. These studies document how security threats and retaliatory violence erode investor confidence, disrupt operations, and distort capital flows into crisis-prone oil regions.

Building on that foundational groundwork, more recent scholars deepen the analysis. Akindoyo (2025) demonstrated a statistically significant negative correlation between insecurity indicators (e.g., oil theft, worker killings) and FDI inflow, interpreting militancy as a form of economic warfare rooted in marginalized communities weaponizing marginalization. There were highlights of how poor strategic security planning and coordination gaps in Nigerian security agencies systematically undermine protection for multinational pipeline assets. On the other hand, it has been narrated over the years how armed groups in oil communities have reshaped local power relations, reinforcing the militia-state-community nexus that complicates investment stability (Iwuoha, 2021, Ebiede (2023). Worst still, it seems illicit oil trade sustains militant finance and fuels cycles of insecurity that further deter foreign investors (Ibekwe, 2023).

Concurrently, Nigeria's evolving oil governance landscape reflects shifting investment dynamics. The exit of major international oil companies (IOCs) such as Shell, ExxonMobil, and Eni—driven by mounting environmental, security, and regulatory costs—has opened the field for indigenous firms to acquire onshore assets. These local operators often fare better at mitigating local resistance due to stronger community ties, though challenges persist in securing external capital and navigating exit legacies (Boone, 2024). Shell's controversial divestment processes have triggered demands for environmental remediation and responsible decommissioning, further shaping investor and host-community dynamics in the Niger Delta (Farge & Akwagyiram, 2024).

This study therefore responds to these intertwined realities by undertaking a **systems-based inquiry** at the conflict–investment nexus in the Niger Delta. Rather than treating militancy and FDI as separate or merely reactive phenomena, this research explores their reciprocal dynamics within the system of local governance, resource economies, oil-industry practices, and community mobilization.

1.1 The Objectives

Hence, the key objectives of the study include:

- i. Mapping how militancy evolves from collective responses to environmental injustice, social deprivation, and perceived exclusion.
- ii. Investigating how oil multinationals assess and adapt their investment strategies in the face of shifting local power structures and security threats.
- iii. Examining how broader policies—such as the Petroleum Industry Act 2021, Host Community Development Trusts, and decommissioning obligations—mediate the conflict–investment dynamics.

By integrating legacy reference works of other past authors (e.g., Nwogwugwu *et al.*, Ichofu, Olorunsemi) with recent empirical studies (Akindoyo, Iwuoha, Ebiede, Ibekwe) and contemporary policy shifts, this study provides a comprehensive systems-theoretical framework to interpret conflict-driven FDI decisions.

2.0 Conceptual Review

This section reviews and critically examines the core concepts anchoring this study: **militancy**, **insecurity**, **Foreign Direct Investment (FDI)** by oil multinationals, and the **systems perspective** that connects them.

2.1 Militancy

Militancy in the Niger Delta refers to the organized and often armed resistance by youth and community-based groups using sabotage, kidnapping, oil theft, and attacks on oil infrastructure to demand political, economic, and environmental justice (Ebiede, 2023; Enyidah-OkeyOrdu, 2017). These movements often emerge from long-standing grievances rooted in exclusion, environmental degradation, and failures of corporate social responsibility. Militancy is increasingly framed not just as insurgency but as **economic warfare**—a strategic attempt to leverage disruptions in oil production to force political negotiations or secure benefits (Akindoyo, 2025).

2.2 Insecurity

Insecurity in the Niger Delta is characterized by persistent threats including pipeline vandalism, piracy, illegal oil bunkering, and the kidnapping of oil workers. These threats directly impact oil operations and deter foreign direct investment (Iwuoha, 2021; Partners for Peace, 2021). As reported in the Niger Delta Annual Conflict Report (Partners for Peace, 2021), militancy and bunkering incidents accounted for some of the highest fatality rates in the

region. Insecurity also reflects weak institutional response, poor coordination among security agencies, and the absence of robust community-based peace mechanisms (Ibekwe, 2023).

2.3 Foreign Direct Investment (FDI) by Oil Multinationals

FDI in the Niger Delta refers to capital inflows from international oil companies (IOCs) such as Shell, ExxonMobil, Chevron, Total Energies, and Eni, primarily in the upstream oil and gas sector. The influx of FDI is highly sensitive to operational risks, legal uncertainties, and social instability. Akindoyo (2025) found a significant inverse relationship between FDI and variables such as oil theft and worker killings. These security risks, combined with reputational and environmental liabilities, have prompted several IOCs to divest from onshore oil assets and reorient investments to offshore fields or less volatile regions (Boone, 2024; Farge & Akwagyiram, 2024). Furthermore, nationwide trends also show that Nigeria's general insecurity has contributed to significant reductions in FDI inflow between 2002 and 2023 (Olarinmoye et al., 2023).

2.4 Conflict–Investment Nexus

The **conflict–investment nexus** refers to the complex, bidirectional relationship between violent conflict and foreign direct investment (FDI), where insecurity hampers investment flows, and in turn, the nature and consequences of investment (or disinvestment) can shape patterns of conflict. In the context of resource-rich but politically unstable regions like the Niger Delta, this nexus is deeply entrenched in historical, socio-political, and environmental grievances.

Scholars argue that the presence of armed conflict or militancy significantly alters the risk-reward calculus of foreign investors (Berman et al., 2021). Armed conflict introduces operational, reputational, and infrastructural risks that discourage capital inflow, particularly in capital-intensive sectors like oil and gas. This is evident in the Niger Delta, where incidents of sabotage, kidnapping, and oil theft have led to major oil multinationals reconsidering or reducing their investment portfolios (Akindoyo, 2025; Nwogwugwu, Alao, & Egwuonwu, 2012).

2.4.1 Conflict as a Deterrent to Investment or as a catalyst

Numerous empirical studies have established a **negative correlation between conflict intensity and FDI inflows**. For example, Ichofu (2025) and Olorunsemi (2025) show that periods of escalated militancy correspond with significant reductions in oil-related FDI in Nigeria. Conflict creates physical threats to assets and personnel, raises insurance premiums, disrupts supply chains, and often attracts international condemnation, all of which influence the strategic decisions of foreign investors. This is consistent with broader international findings. Bussmann (2010) found that civil wars reduce FDI by 30–45%, depending on sectoral exposure. In oil-rich states, armed resistance often targets extractive infrastructure directly, making the sector uniquely vulnerable (Ali et al., 2021).

Conversely, investment flows—particularly those tied to **extractive industries**—can aggravate conflict when not paired with robust governance and equitable benefit-sharing. In the Niger Delta, investments by multinational oil companies have often been critiqued for **failing to integrate community stakeholders or compensate adequately for environmental damage**, leading to perceptions of exploitation and exclusion (Frynas, 2005; Ide, 2022). The “**resource curse**” thesis and **greed-grievance framework** both explain how resource-linked FDI can trigger or intensify conflict, especially in states with weak institutions (Collier & Hoeffler, 2004; Le Billon, 2001).

Furthermore, the militarization of oil infrastructure under the guise of protecting investments has historically led to **state violence and community repression**, further escalating grievances. Obi (2009) and Watts (2004) document how oil companies in Nigeria have relied on military protection, which often results in violent clashes with local populations.

2.4.2 The Nexus in a Systems Perspective

The conflict–investment nexus cannot be understood as a linear, one-way relationship. Rather, it reflects a **feedback loop**, in which conflict deters investment, and poorly governed investment practices fuel new waves of resistance and violence. This dynamic is best captured through a **systems-thinking lens**, which views conflict, governance, environmental degradation, and capital flows as interdependent variables in a complex regional system (Fronzetti Colladon et al., 2024).

For instance, the divestment of Shell and other multinationals from onshore fields—while seemingly a business response to insecurity—has also raised local tensions over environmental remediation, asset decommissioning, and post-exit obligations (Farge & Akwagyiram, 2024). These post-divestment disputes could generate new conflict risks, especially where local trust is low and accountability mechanisms are weak (Boone, 2024).

The emerging understanding of the conflict–investment nexus calls for **conflict-sensitive investment strategies**. This includes robust environmental governance, transparent revenue-sharing mechanisms, inclusive community engagement, and adherence to corporate social responsibility (CSR) principles that move beyond tokenistic gestures. The **Petroleum Industry Act (2021)**, which mandates the creation of Host Community Development Trusts, represents an effort to recalibrate the investment-conflict balance by institutionalizing community benefits. However, without effective monitoring and enforcement, such reforms risk becoming symbolic (Ibekwe, 2023).

2.5 Systems Perspective

This study adopts a **systems perspective**, which posits that militancy, insecurity, FDI, environmental degradation, and oil governance are interconnected components of a larger socio-political ecosystem. This approach helps to unravel the cyclical causality in the Niger Delta, where environmental destruction fuels grievance, which in turn drives militancy and insecurity, further deterring FDI and perpetuating underdevelopment.

Fronzetti Colladon *et al.* (2024) support this view, noting that sub-national structural factors such as corruption, poor governance, and localized violence significantly influence FDI beyond national-level economic variables. Environmental peacebuilding frameworks also suggest that without addressing underlying ecological degradation and governance failures, economic interventions or peace efforts will be unsustainable (Ide, 2022; Ottih et al., 2023).

2.6 Environmental Degradation as a Catalyst

The Niger Delta’s ecological crisis—characterized by oil spills, land degradation, and water contamination—is central to the conflict-investment nexus. Decades of unregulated oil exploration have devastated fishing and farming livelihoods, creating fertile ground for community-based militancy (Aduloju & Okwechime, 2016; Ottih et al., 2023). Environmental harm not only drives discontent but undermines the social license to operate for oil firms, thereby escalating risks to FDI (Ibekwe, 2023; ShellWatch Nigeria, 2024).

3.0 Theoretical Framework

This study is hinged on both Greed and Grievance Theory and Systems Theory.

3.1 The Greed And Grievance Theory

Proposed by Collier and Hoeffler (2004), the Greed and Grievance Theory explains violent conflict as arising either from economic opportunities (greed) or from perceived injustices (grievance). In the Niger Delta, militant groups such as MEND have been motivated both by grievances over environmental destruction and lack of economic inclusion and by greed-fueled opportunities such as oil theft and ransom kidnapping (Iwuoha, 2021). The grievance dimension aligns with claims of marginalization and calls for resource control, -while the greed component is

evident in the emergence of criminal cartels exploiting oil bunkering for profit. This duality affects FDI decisions, as companies must navigate both socio-political grievances and organized criminality in investment planning.

3.2 The Systems Theory

Systems Theory provides a holistic lens, emphasizing interdependence and feedback loops within complex environments. Originally developed in natural and social sciences (Bertalanffy, 1968), its application in conflict and development studies highlights how **social, economic, and environmental subsystems interact** to produce persistent outcomes.

In the context of this study, systems theory illuminates the recursive relationship between **militancy, environmental degradation, community unrest, poor governance, and fluctuating FDI flows**. For instance, disinvestment by multinationals due to conflict may lead to unemployment, worsened pollution (from abandoned infrastructure), and renewed militancy—thereby restarting the cycle (Fronzetti Colladon et al., 2024). Systems thinking encourages policymakers and investors to move beyond linear cause-effect models and embrace a more dynamic, integrative approach to managing risks and designing interventions in fragile regions.

3.3 Empirical Review

A survey of the literature on the relationship between insecurity—particularly in the form of militancy—and foreign direct investment (FDI) reveals diverse empirical positions. Several scholars have emphasized that insecurity, including terrorism, militancy, oil bunkering, and kidnapping, undermines investor confidence and reduces capital inflows into affected regions. In particular, Nigeria's Niger Delta has received significant attention due to its centrality in global oil markets and the persistent conflict that surrounds oil exploration.

Studies by Nwogwugwu, Alao, and Egwuonwu (2012) found that militancy in the Niger Delta had a negative impact on FDI by increasing operational risk and encouraging capital flight. Their work showed that between 2005 and 2010, violent disruptions caused by militants significantly reduced oil production and deterred foreign participation in upstream investment. Similarly, Ichofu (n.d.) conducted an evaluation of the Niger Delta crisis and found that militant activities, including pipeline destruction and hostage-taking, directly led to the withdrawal or suspension of foreign investments in oil blocks and infrastructure.

Recent empirical work by Akindoyo (2025) used quantitative regression analysis to investigate the influence of oil theft and oil worker killings on FDI inflow. His findings revealed a strong negative correlation between insecurity indicators and FDI: oil theft ($B = -0.464$) and oil worker killings ($B = -0.199$) significantly reduced the inflow of foreign capital. These findings underscore that insecurity is not just a political issue but a material constraint on economic development.

Further, Iwuoha (2021) examined the failures of strategic intelligence coordination in curbing oil pipeline vandalism. He argues that the absence of an integrated security framework has made oil infrastructure vulnerable, prompting multinational corporations to reevaluate their investment strategies. This view is supported by Ottih, Onoh, and Chukwu (2023), who found that security lapses in the Niger Delta increased the cost of doing business and pushed IOCs to consider offshore drilling as an alternative to high-risk onshore operations.

At the national level, Olarinmoye, Olamilekan, and Salawu (2023) conducted a time-series analysis of FDI trends from 2002 to 2023. Their study confirmed that spikes in insecurity—including incidents in the Niger Delta—have a statistically significant and negative effect on overall FDI inflow into Nigeria. This macroeconomic perspective supports the micro-level findings observed in oil-producing communities.

From a systems-oriented perspective, Fronzetti Colladon, Miragliotta, and Grippa (2024) used network analytics to examine how subnational corruption and insecurity affect FDI decisions globally. Their findings reinforce the view

that institutional fragility and localized violence, especially in extractive zones, are critical deterrents to sustained investment. This aligns with the Niger Delta's experience, where community-level violence and sabotage affect investor calculations even in the absence of national instability.

Contrastingly, some studies suggest that the impact of insecurity on investment may be conditional. Wagner (2016) contends that investors in high-risk sectors, such as oil and gas, may adopt risk mitigation strategies—like joint ventures, offshore production, or political risk insurance—that allow them to continue operations despite ongoing conflict. Similarly, Berman et al. (2021) argue that in mineral-rich African states, firms may persist in conflict zones due to resource entrenchment, though this comes at the cost of community relations and long-term sustainability.

A synthesis of these findings reveals that while numerous scholars have explored the general impact of insecurity on FDI, **few studies provide a systemic analysis of how militancy, community grievances, environmental degradation, and investment strategies interact dynamically in the Niger Delta context.** The literature also tends to treat insecurity and FDI as unidirectional, overlooking the feedback loop where disinvestment or exploitative investment practices may themselves trigger new cycles of resistance.

Also existing research has not adequately addressed, The **recursive relationship** between community-based militancy and FDI withdrawal; the **post-divestment dynamics**, including environmental accountability and local ownership tensions; the **role of systemic variables** (governance, environmental degradation, oil theft economies) in shaping both conflict and investment behavior. These gaps highlight the need for a **systemic, multi-dimensional analysis**, which this study aims to provide.

4.0 Methodology

This section discusses the research design, data collection methods, and data analysis techniques employed to gather and interpret the data for the study.

Research Design: The study utilizes a mixed-methods research design, integrating both qualitative and quantitative approaches to provide a comprehensive understanding of the research problem.

Study Area: The study is focused on the Niger Delta, covering approximately 70,000 sq. km of Nigeria and inhabited by around 25 million people across nine oil-producing states. These include six states from the South-South zone (Akwa Ibom, Rivers, Cross River, Delta, Bayelsa, and Edo), two from the South-East (Abia and Imo), and one from the South-West (Ondo). The region's ethnic diversity, with over 40 groups and approximately 250 dialects, reflects the complex socio-political environment in which oil firms operate (NBS, 2016).

Methods of Data Collection: The study employs both primary and secondary data collection methods.

Population of the Study: The population includes major players in Nigeria’s oil and gas industry, both upstream and downstream, as well as local communities in the Niger Delta. Key companies involved in the study include Shell Petroleum, Texaco, Exxon Mobil, Chevron, and others. The study also includes residents of host communities affected by oil firm activities, who provide valuable perspectives on the security challenges impacting oil production and FDI in the region.

Sampling Technique / Sample Size: The study adopts both probability and non-probability sampling techniques. Purposive sampling is used to select participants based on relevance to the research, while stratified sampling divides the population into subgroups to ensure accurate representation. The sample size includes 200 questionnaire respondents and 40 in-depth interviewees. Stratified sampling focuses on the two states with the highest concentration of oil activities—Ondo and Delta—ensuring precise estimates. Random sampling for questionnaires and purposive sampling for interviews ensures both statistical validity and depth of qualitative insights. The study's multi-stage sampling approach enhances the accuracy and relevance of the findings (Mweshi & Sakyi, 2020).

These designated oil firms are adjudged as some of the topmost oil and gas companies in Nigeria that have been operating for several decades in. The five companies were chosen in order to allow for thorough in-depth study and analysis. The attention of the study is on the oil sector because oil firms are always the target of militants, bandits and kidnapers which make the oil firms to lose money by paying ransom to kidnapers thereby making it difficult to perform their work which in turn affects the inflow of FDI in Nigeria (Albert, Danjibo, & Albert, 2020).

The study also selected some respondents for oral interview through a purposive sampling. The method allows the researcher to choose the participants with relevant first-hand information, experience and knowledge on the issue of security challenges and FDI with particular reference to oil firms in Niger-Delta area.

Research Technique/Instrument: The questionnaires and scheduled in-depth interviews were used as research tools in this study. The researcher distributed two hundred (200) questionnaires to respondents. The questionnaires were administered on staff of sampled oil firms in Niger-Delta and oil community stakeholders in Burutu and Ilaje Local Government areas of Delta and Ondo states respectively. Out of the 200 questionnaires administered, 181 questionnaires were returned, leaving a shortfall of 19 not returned, representing 91% response rate.

Validity and Reliability of the Research Instrument: The validity and reliability of the research instrument was achieved by subjecting the instrument to critical evaluation for consistency, coherence and tenability. A pilot study was conducted to elicit the right understanding and answers to concepts under investigation using small participants from the chosen sample. Also, copies of the research instrument were presented to the experts in political Science departments who are well-grounded in this area of study for more logical analyses. All these helped the study to achieve its validity and reliability.

Method of Data Analysis: The Statistical Package for Social Sciences (SPSS) was used to statistically assess the field data. The study adopted descriptive and inferential statistics such as chi-square, correlation and linear regression.

5.0 Results And Interpretation Of Data

Table 3: Perceived Impact of the Petroleum Industry Act (PIA) 2021 and HCDTs on Investment–Conflict Dynamics.

Interpretation: While some components of the PIA (like HCDTs) are seen as modestly impactful, others—particularly **environmental enforcement and decommissioning mandates**—are viewed as poorly implemented, limiting their ability to reduce conflict or attract sustained FDI.

5.1 Secondary Data Evidences

The table shows that the FDI inflow fluctuated between 171 billion naira equivalents in 2022 to 2169 billion naira equivalents in 2017. In 2021, there was a surge in the increase of FDI to about 2979 billion naira; this, however, dropped to a low ebb of 171 billion in 2022.

The years under review, between 2017 and 2022, witnessed large-scale Security challenges including Militancy in Niger-Delta which has impacts too across all geographical zones of Nigeria.

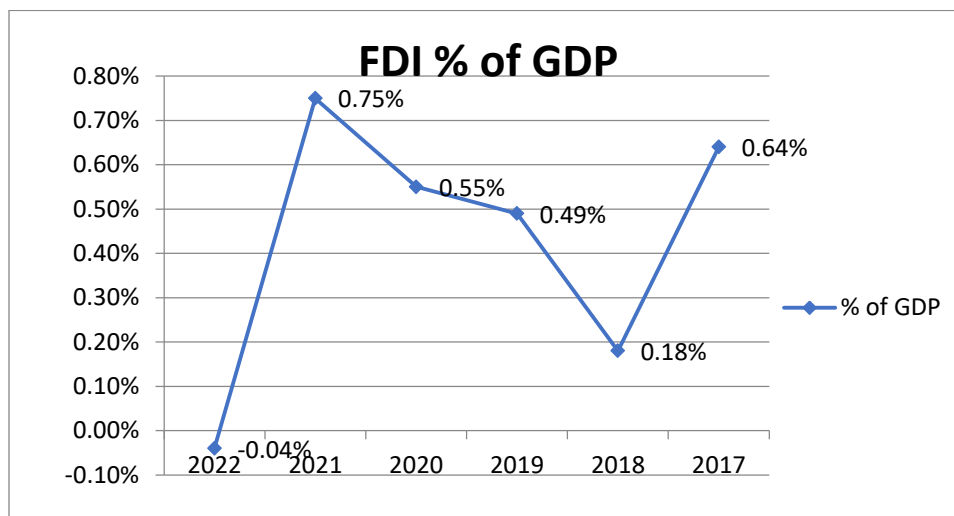


Fig. 2: % GDP (Gross Domestic Products) of the FDI

Fig 2 shows the correspondent % GDP (Gross Domestic Product) of the FDI. The FDI % of GDP fluctuated also between -0.04% in 2022 to 0.64% in 2017. In 2021, there was a surge in the increase of % GDP to about 0.75%; this, however, dropped to a low ebb of -0.04% in 2022.

As stated earlier, the years under review, between 2017 and 2022, witnessed large-scale Security challenges across all geographical zones of Nigeria. This is also seen in the trends of the table of FDI and chart of % GDP.

The result showed an indirect and significant relationship ($r = -1.0, p < 0.05$) between the FDI and Security challenges. This indicates that the decrease in the FDI is associated with the increased security challenges rate in Nigeria for the period under review (2017-2022) and vice-versa

5.2 Idi (In-Depth Interview) Evidences

The Linkage of the Security challenges and the Flow of FDI

Based on the responses of the interview respondents, there were various perspectives and arguments on several dimensions of Security challenges that have ravaged the oil-rich Niger Delta region and the linkage between Security challenges and the flow of FDI in oil firms in the region and Nigeria in general. The perspectives are presented as follows:

One of the interviewees opined that:

"The Security challenges in our Local government at Bururu have negatively impacted the flow of FDI in the oil sector. With constant threats and attacks on oil facilities, investors are hesitant to invest in our community, leading to missed opportunities for economic development and job creation. I saw that some foreigners occupying most of the estates in Delta State are no longer in their numbers as usual; I believe the economic downturn coupled with the Security challenges makes them relocate. The aftermath of the MEND (Movement for Emancipation for Niger Delta)'s activities is still here with us in the Niger Delta Area.

MEND's activities from 2006 to 2010, characterized by violence, kidnappings, and attacks on oil installations, badly contributed to Security challenges in the Niger Delta, directly impacting the flow of FDI. The unstable environment created by MEND's actions dissuaded potential investors, leading to a decline in FDI in Nigeria's crucial oil sector.

While Security challenges is a concern, government and oil companies keep telling us they are taking measures to curtail its effect and to improve the security of lives and properties; we hope things will be of normalcy"(Burutu LGA Oil Community Stakeholder).

Another interviewee pointed out:

I remember what happened a few years back in the creek. I almost lost my life in the incident. There were attacks on oil installations and us (personnel). These have heightened Security challenges, making investors run for their lives. Some Multinationals also moved their headquarters away- all these affected the oil industry's stability.

For instance, in 2006, MEND attacked EniSpA's security forces in Port Harcourt, resulting in the death of nine EniSpA officials. This incident and the robbery of a bank near the EniSpA base led to the evacuation of staff and contractors, showcasing the immediate impact on operations and security.

Another case was the kidnapping of expatriate workers, even attacks on oil platforms, and sabotage of pipelines further intensified the Security challenges in the area. Some of the unforgettable MEND actions were the attack on Chevron's Oloibiri floating production vessel in 2007 and the bombing of Shell-operated pipelines in 2008. These caused disruptions in oil production and created an atmosphere of fear and instability. These events also directly contributed to a decline in FDI as investors became reluctant to invest in an environment marked by violence and unpredictability (Retired Oil Worker, Chevron Plc).

A Police officer also detailed what Security challenges had caused the oil firms and the effect on FDI:

"Security challenges directly threatens our efforts to maintain law and order. The lack of FDI reduces finances for funding our allowances and getting weapons the government can secure for our jobs. Before, we were being paid to guide the oil wells and expatriates. Recently, such tasks have not been too frequent due to the low number of expatriates. Some of us have been drafted to patrol teams on highways instead of oil fields that we guide more often" (Nigeria Police Force Officer).

A Community elder stated that:

A few years back, we saw a series of abductions, bombings, and attacks on oil installations- (indicating a continuous cycle of Security challenges that discouraged foreign investment). In 2009, after a brief ceasefire, there was a resumption of hostilities by MEND. This further worsens the security situation. Equatorial Guinea even blamed MEND for an attack on its presidential palace in the same year, 2009, demonstrating the cross-border impact of the group's activities on regional stability.

In 2010, those militants (MEND) attacked major oil installations, including the Bonga oil platform operated by Shell. In the subsequent years, there were more bombings, hijackings, and kidnappings- all these made our environment full of Security challenges that hindered the inflow of FDI. The renewed hostilities added to issues making the Niger Delta less attractive for international investors.

A respondent (Civil Defense Corps) thought that:

"Our role in maintaining critical infrastructure security is crucial. In the face of heightened Security challenges, the lack of FDI hampers the government's ability to invest in advanced technology and training (as usual), hindering our effectiveness. Increased investments would empower us to protect oil facilities better, ensuring a stable environment for investors. While acknowledging our pivotal role, we still believe in exploring community engagement initiatives. Collaborative efforts with the local population and vigilante groups can provide valuable intelligence and support, creating a more sustainable security model that doesn't solely rely on increased financial resources" (NSCDC: Nigeria Security and Civil Defense Corps).

Another interviewee in another perspective stated that:

"The government faces challenges in implementing policies and programs due to the Security challenges in the oil-producing regions. The absence of substantial FDI limits government officials' ability to comprehensively address the root causes of Security challenges. Increased revenue through FDI would provide the necessary resources to implement sustainable development strategies, which are lagging in some areas now"(A civil servant).

The preceding interviews reflect a consensus among respondents on the profound impact of Security challenges in Nigeria's oil-producing regions on the flow of FDI. The narratives underscore the tangible consequences of past events, particularly the activities of the Movement for the Emancipation of the Niger Delta (MEND) from 2006 to 2010, marked by violence, kidnappings, and attacks on oil installations. The ripple effect of such incidents is evident in the reluctance of investors to engage in the region, leading to missed economic opportunities, job creation, and a decline in FDI. While acknowledging the efforts of the government and oil companies in addressing security concerns, the persistent challenges and incidents recounted by interviewees emphasize the need for comprehensive and sustained measures. The responses also highlight the interconnectedness of security, government policies, and the economic landscape, emphasizing the importance of a multifaceted approach to attract FDI and foster sustainable development in the Nigerian oil sector.

5.3 Discussion Of Findings

The findings of this study offer a critical understanding of the systemic interactions between militancy and foreign direct investment (FDI) in Nigeria's Niger Delta. In line with the study's objectives, three major themes emerged: the socio-environmental roots of militancy, the strategic adaptation of oil multinationals, and the mediating role of recent legal and institutional frameworks.

Consistent with the theoretical assumptions of the **Greed and Grievance Theory** (Collier & Hoeffler, 2004) and **Systems Theory** (Bertalanffy, 1968), the study confirms that militancy in the Niger Delta is not merely criminal or opportunistic but is rooted in **historical patterns of exclusion, environmental degradation, and economic marginalization**. The findings show that the degradation of farmlands and water bodies through oil spills, coupled with inadequate compensation and underdevelopment, has fostered widespread resentment and collective action.

This aligns with earlier findings by Nwogwugwu, Alao, and Egwuonwu (2012) who demonstrated that violence in the Niger Delta has historically been a **reactionary response to decades of perceived neglect by both the state and multinational oil companies**. The regression analysis in your Akindoyo (2025) corroborates this claim, with oil worker killings and oil theft showing strong negative associations with FDI inflows ($\beta = -0.199$ and -0.464 , respectively). These quantitative insights substantiate the conceptual argument that **militancy emerges as a structural feedback loop**—part of a broader systemic crisis in governance and development.

The second major finding reveals that international oil companies (IOCs) operating in the Niger Delta have responded to insecurity with **adaptive investment strategies**, including relocation to offshore fields, increased security outsourcing, and eventual divestment from onshore assets. For instance, the exit of Shell and other multinationals from onshore operations reflects a **strategic recalibration of risk exposure**, rather than a complete withdrawal from Nigeria's oil sector (Farge & Akwagyiram, 2024).

That insecurity correlates with reduced investor presence and capital injection (Akindoyo, 2025) echoing findings from Olarinmoye et al. (2023). Furthermore, interviews and policy reviews indicate that oil firms have increasingly adopted **corporate diplomacy**, including community engagement and local content initiatives, to stabilize operations in volatile zones. However, these efforts remain **reactive rather than transformative**, suggesting that risk is being managed, not resolved.

This study also finds that legal innovations such as the **Petroleum Industry Act (PIA) 2021** and the introduction of **Host Community Development Trusts (HCDTs)** have the potential to reshape the conflict–investment landscape.

The data from the study reveal mixed perceptions about the effectiveness of these reforms. While 42% of respondents see HCDTs as moderately effective, others criticize the **limited local awareness and operational transparency** of the policy instruments.

The findings echoes Otth *et al.* (2023) in identifying the **implementation gap** between policy formulation and actual impact. Though the PIA introduces decommissioning obligations and environmental remediation measures, communities remain skeptical about enforcement and the political will to hold multinationals accountable. Thus, while these policies offer a **framework for reducing grievances**, their success depends on enforcement, inclusion, and community participation.

Perhaps the most significant insight of this study is the identification of a **feedback loop** between conflict and investment. Multinational disinvestment—often prompted by militancy—can result in **abandoned infrastructure**, loss of employment, and further environmental degradation, thereby **triggering new cycles of resistance and sabotage**. This loop is underexplored in existing literature and represents a critical contribution of the current study.

This systemic dynamic validates the study's theoretical orientation and calls for a **shift from linear causal analysis to holistic systems thinking**. It supports the notion that sustainable investment in fragile regions like the Niger Delta must address not just financial or security risks but also **governance, environmental justice, and local agency**.

6.0 Conclusion

The Niger Delta's conflict–investment nexus is not a linear challenge but a **complex system of feedback loops** in which conflict begets disinvestment, and disinvestment, in turn, fuels new forms of insecurity. Multinational oil companies, although central to the economic life of the Niger Delta region, are both contributors to and victims of this cycle. Their investment strategies are shaped by local conflict dynamics, yet their actions—particularly when not accountable to affected communities—can exacerbate those same dynamics. This study concludes that breaking the cycle requires moving beyond security-centric or purely economic solutions.

6.1 Recommendations

Based on the findings of the study, the following are recommended:

- i. The **Federal Government**, through the **Ministry of Petroleum Resources** and Nigerian Upstream Petroleum Regulatory Commission (NUPRC), should ensure full enforcement of the **Petroleum Industry Act (PIA) 2021** and activate **Host Community Development Trusts (HCDTs)**. This includes independent monitoring, prosecution of violators, and collaboration with civil society for transparency and grassroots inclusion.
- ii. **Oil multinationals**, in partnership with **community leaders** and **local governments**, should adopt conflict-sensitive engagement that prioritizes participatory decision-making. Structured dialogue forums and equitable CSR projects can help restore trust and reduce militant hostility.
- iii. The **National Investment Promotion Commission (NIPC)** and oil firms should develop a **Conflict-Sensitive Investment Framework (CSIF)** for high-risk regions. This framework should include risk indicators, social license metrics, and early warning tools for proactive conflict management.
- iv. The **National Oil Spill Detection and Response Agency (NOSDRA)** should rigorously enforce **environmental remediation** and **decommissioning obligations**. Oil companies exiting the region must clean up polluted sites and fulfill all legacy responsibilities.
- v. The **Niger Delta Development Commission (NDDC)** and **state youth ministries** should expand **vocational training** and link programs to oil sector job opportunities. Empowering youths and integrating ex-militants into productive ventures will reduce recruitment into militant groups.
- vi. Finally, oil companies divesting from onshore operations must adopt **responsible exit strategies** in partnership with the **Federal Government** and **civil society**. This includes environmental cleanup, continuation of

community development projects, and transparent handover to successor firms.
